1. Watch or listen to TV Mass

2. Read the Mass readings (daily during prayer time)  
- [www.usccb.org](http://www.usccb.org)
3. Pray the Rosary
4. Pray the Chaplet of Divine Mercy
5. Make a daily "Spiritual Communion" welcoming Jesus into our heart and life
6. Stop by Church for private prayer
7. Pray to our Our Lady (Mary)  
- ask her prayer to join with ours for those with greatest need
8. Develop the habit of offering a prayer daily for the dying, that our prayers may help escort them to Heaven.
9. Call someone to say "hi" and offer a word of encouragement and perhaps a prayer.
10. Pick up your Bible. Spend 10 minutes a day reading. I suggest beginning with one of the Gospels.
11. In your daily prayers, pray for those suffering the greatest from the effects of the pandemic.

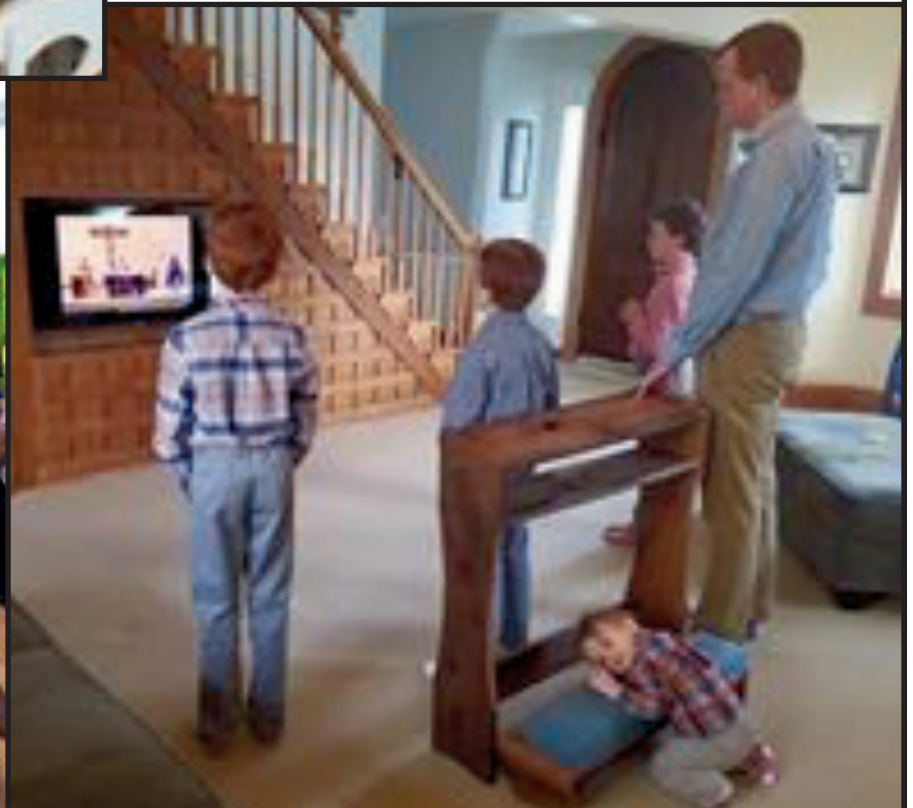
