DECREE

Defining Deanery Boundaries

In Nomine Domini. Amen.

Whereas I wish to foster better pastoral care, and common and efficient action;

Whereas there have been several alterations of parishes since the deanery boundaries were redefined by my predecessor;

Whereas I wish to provide clarity regarding territorial boundaries;

Therefore, in accord with cc. 48, 381 §1, and 391 §1, I hereby define the Deanery Boundaries within the Diocese of Fargo as follows:
