## Financial Obligation Contract for Nursery through Grade 8 2025-2026 School Year

In recognition of the financial obligations of St. John Paul II Regional School and the need for parental support through tuition, fundraising, and cooperation, I acknowledge the following responsibilities and obligations to St. John Paul II Regional School for the 2025-2026 school year by my signature below.

For grades K-8, tuition rates for St. John Paul II Regional School are determined by parish involvement. Families belonging to and tithing a Catholic parish can return the Parish Certification Letter (contained in this packet), completed and signed, to be eligible for the reduced tuition rates. Families that do *not* return a Parish Certification Letter will be assessed with the *regular* tuition rates.

1. I agree to pay the tuition stated by the following method (choose one)

INITIALS

- ☐ I/we will pay the full year tuition payment by August 15, 2025
- ☐ I/we will make 2 payments, one August 15, 2025 and the other January 15, 2026.
- ☐ I/we will make 10 monthly payments from August 15, 2025 to May 15, 2026.

2. Regarding FEES; I agree to pay (1) a Family Registration Fee, \$400 for K-8 (before Mar. 15, 2025 this fee is \$300) or \$400 for PreK3 and 4, (2) a \$125 Technology Fee per student K-8, (3) \$200 in mandatory Christmas Raffle Tickets per student Pre-K to 8 throughout the school year, and (4) a \$650 Fundraising Covenant Fee if I want to opt out of volunteering at one of the four major fundraisers.

3. I agree to use FACTS payment management software to pay my tuition via an automatic checking or savings account withdrawal. Fees are applied for multiple tuition payments: 1 payment-\$25 fee, 2 payments-\$25 fee, 10 payments-\$55 fee. Refer to your FACTS agreement online for additional information.

4. I understand that school record transfers will be delayed if my tuition and fees are not paid in full. I agree that should my account fall more than 45 days in arrears I will contact the school office to discuss my account.

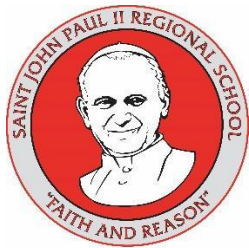
5. I understand final decisions on the above are determined by the Principal and that potential hardship in meeting financial responsibilities will be considered on an individual basis. Any need for financial assistance must first be presented to the Tomorrow's Hope Foundation.

6. I agree to pledge myself to work with the school staff, administration and faculty to the betterment of my child. I understand that education works on a relationship between school and home. When in the view of a school relationship that is no longer viable, parents are required to withdraw their child.
