Baptism Preparation for Parents of Children Under the Age of Seven

Dear Parents,

We rejoice with you on the upcoming baptism for your child. Your Catholic family warmly welcomes you and promises to support you in your endeavor to be a Christian parent. Please:

- 1. Read and review the contents of this welcome packet carefully. It contains important information you need to know.
- 2. **Register for our baptism class** for parents by completing the registration form and submitting a copy of your child's birth certificate. Please <u>take the registration form home</u> and discuss the questions with a spouse or family member. You will be registered only after we have both of these documents (unless the child is not yet born; in that case, only the registration form is necessary).
- 3. **BOTH PARENTS SHOULD PARTICIPATE IN THE CLASS.** If you have a special need that makes this difficult, <u>please speak with me</u>.
- 4. After you have completed the paperwork and the online class, you will be scheduled to celebrate the sacrament of baptism with your family.

On behalf of Fr. Felix Osasona, MSP, our pastor, and all of the families here at St. Mary Magdalene, we congratulate you as you approach this special celebration and invite you to continue to worship with us at Sunday Mass each week.

You and your family remain in our prayers; we ask you to join us in praying for the growth and life of all the people of our parish.

Choosing your child's sponsor (two persons together are usually referred to as godparents) is one of the most important decisions you will make. Godparents represent the Church and as such, it will be their responsibility to help your child in his or her Catholic Christian formation and education. Therefore, you should verify whether the sponsor or godparents you have in mind meet the following criteria.

Mandatory Criteria for Godparents

- 1. Must be a baptized Catholic, 16 years of age or older.
- 2. Have received the sacraments of confirmation, reconciliation and Eucharist (Communion).
- 3. Is a Catholic in good standing with the Church (free to take the Eucharist).
- 4. If either is married, he/she must be in a valid marriage—a Catholic wedding that was witnessed by a priest or deacon and two Catholic witnesses.
- 5. Cohabiting couples cannot serve as a godparent. Sexual relationships of any kind outside of marriage disqualify a person from serving as a godparent.
- 6. Divorced persons may be godparents as long as they are not remarried outside of the Church.
- 7. Is presently practicing his/her faith (attending Catholic Mass each Sunday, registered in his or her home parish, able to receive Communion and participating in the sacramental life and activity of the Church.
- 8. May not be a parent of the child to be baptized.

One Catholic sponsor is sufficient; however, two godparents may be chosen, male and female. No more than two sponsors' names will appear on the certificate of baptism.

Among your family and friends, is there anyone who stands out as a good example of someone who practices his/her faith? Remember that the godparents may influence your child, not only in the practice of the faith, but also in the virtues of Christian life. Ask God in faith to help you discern the best godparents for your child.

A Christian witness is a <u>baptized **non-Catholic** Christian</u> who serves <u>along with</u> one Catholic Sponsor.

Anyone who has EVER been baptized in the Catholic Church MAY NOT serve as a Christian witness.

Mandatory Criteria for Sponsors/Godparents

"Good standing with the Church" means that this person is a Catholic who has received the sacraments of initiation (baptism, confirmation, Eucharist), penance and if married, he/she must be in a valid Catholic marriage. A faithful candidate is one who attends Mass regularly, prays in the home, shares the faith with family and when possible participates in active ministry in his/her parish. A divorced Catholic who is not remarried or cohabiting can be a godparent.

Why is it important to choose Catholics who practice the faith? As representatives of the Catholic Church, it is the obligation and responsibility of the godparents to give your child a good example of lived faith so that your child may grow to have a loving relationship with God and his Church. Children learn best by observing—"faith is caught, not taught."

Can a man sponsor a girl child? Can a woman sponsor a boy? Yes. The sponsor does not have to be of the same sex as the child.

May a Christian of another faith be a sponsor? A person baptized in another Christian faith may be a Christian Witness as long as your child has one Catholic godparent as well. Anyone who has EVER been baptized in a Catholic Church MAY NOT serve as a Christian witness.

May a Christian of another faith be a Godparent? A Christian witness is a <u>baptized non-Catholic</u> <u>Christian</u> who serves <u>along with</u> one Catholic Sponsor. A person baptized in another Christian faith may be a Christian Witness as long as your child has at least one Catholic godparent as well. This person should be practicing his or her faith according to the norms of his or her faith tradition, including regular participation in Sunday worship. Anyone who has EVER been baptized in the Catholic Church MAY NOT serve as a Christian witness. Such a person is considered to be a non-practicing Catholic.

Can anyone who is living together without being married be a sponsor? No, Catholics who are cohabitating in a sexual relationship (either heterosexual or homosexual) without being married to each other in a Catholic ceremony are not eligible to serve as sponsors.

What if the godparents cannot attend the ceremony? It is acceptable to have a proxy.

What if I can't find a sponsor for my child who meets these guidelines? Let us know, and we can find a practicing Catholic from among our parishioners who will serve as a sponsor for your child. Every person who is baptized must have at least one sponsor. This person may be male or female for either a boy or a girl.
