1. **Opening Prayer** - Ms. Anderson

2. **Magic of Ireland Event** - Ms. Farrell

- a. Parish fundraising event scheduled for Saturday, March 2nd following the 5pm mass
- b. Invitation to attend and invite others given the connection between the parish and school we are one
- c. Consider at least one table of 8-10 people for each grade level; Mrs. McAlvin and Ms. McGovern volunteered to serve as table captains
- d. Additional volunteers needed to support the event

3. **Financial/ Budget Report** - Ms. Portonova

- a. Report included the financial information through December
- b. Budget is based on 180 students
- c. SSPJ School has ran in the red for the last 3 years, but the extra \$100,000 in fundraising helps to offset what the parish gave
- d. The school is \$30,000 over in payroll for nursery and PreK
- e. The March/April budget will be presented to the Diocese
- f. Teachers in 1 or 2 years will be entitled to benefits
- g. Budget can be based on confirmed enrollment numbers for next year only currently there are 124 students
- h. Parents have requested to donate air conditioners to classrooms, but we would need an HVAC analysis and it is recommended that we have three years of profit before we can spend money on it
- i. The boiler system in the main school is 50 years old and we need to anticipate its replacement
- j. Delinquent tuitions exist from last year. Tuition payments that are not being met will be addressed with phone calls and deadlines. Some parents are not responding at all. A student will not be able to return to school if these requirements are not met.
- k. Discussion to consider adding mandatory fees (i.e. Christmas Car Raffle) to the FACTS tuition payment system
- l. Issues exist with the permit about the carnival with particular concerns about the side lot. We are encouraged to write letters to the town to advocate for the use of the lot for the carnival.

4. **Guild Report** - Mrs. Jennine Cullen and Mrs. Deborah Radosta

- a. Final profit thus far is \$45,014.61
- b. Consideration for another Bingo night in the spring

- c. Upcoming fundraisers include the Father/Daughter Dance, Mother/Son event and Fashion Show
- d. The parish is taking over this year's Gala with the Magic of Ireland event
- e. Easter Decorations consider having the school and students decorate the church. Dr. Lisa Stephen had organized this in prior years, and will still order the flowers from Hitherbrook, but assistance is needed with decoration. Will take place at 10am on Saturday, April 20th.

5. **Principal's Report** - Ms. Diane Anderson

- a. Brochures were shared regarding the Early Childhood, Elementary and Academy grades
- b. Students from St. Joseph's have been invited to visit and tour the school building. A Sign Up Genius is available for assisting with the Thursday night Open House.
- c. Security
 - i. Security team in progress Ms. Sehne will forward a list of approximately 25 approved volunteers to Mrs. Radosta. Mrs. Radosta and Mrs. Greubel will collaborate on this together and set up a Sign Up Genius to build a schedule for the security team volunteers.
 - ii. Sheriff/ Police Department may offer community outreach and training
 - iii. Discussion regarding the RAVE app used in other schools
 - iv. High visibility and control from the police department
 - v. Suggestion to have safety and security as a standing committee, not just for a sporadic time period. Consideration to be built into the by-laws.
- d. A current WiFi issue in the Monte Building is being addressed. The phones are not always available, and there are no landlines available. Walkie talkies are available for communication, however.
