Required Documentary Evidence: (Photocopies not acceptable)

- Certificate of Baptism for the Catholic party issued within the past six months or Certificate of entry into the Catholic Church by Profession of Faith.¹
- Original or certified copy of the marriage license.
- Original or certified copy of the divorce decree.
- Two Affidavits of freedom to marry if the Petitioner is not Catholic.

¹ If the Baptismal Certificate is unavailable the following is to be presented:

- Letter delineating the efforts that were made to obtain the certificate, include proofs of the efforts.
- If available certificate of First Communion and/or Confirmation
- Affidavit of one or two reliable and trusted witnesses who can testify to the baptism received (CAN. 876: To prove the conferral of baptism, if prejudicial to no one, the declaration of one witness beyond all exception is sufficient or the oath of the one baptized if the person received baptism as an adult.) The witnesses should be from those present at the baptism.
