Dear Fellow Parishioners of St. Patrick and St. Raphael.

On behalf of so many people who are impacted by your financial contributions, thank you! Consider some of the benefactors of your kindness: those who are hungry and without a place to stay, students in our Catholic schools and faith formation programs, pilgrims from around the world, parishioners who are hospitalized and homebound, engaged couples preparing for marriage, and families welcoming infants into God's family at baptism, and those mourning the loss of loved ones.

Sacramentally, our numbers remained consistent. Continue to encourage young couples to celebrate their wedding vows at church and later to bring their children forward for baptism and First Communion. Even if they have been married outside of the community of the church, we can still bring God's sacramental grace to them afterward.

Regarding income, our parishes are struggling significantly. Note the lower incomes listed as "Envelopes," the funds you offer via budget envelopes, distributions from IRAs, and Electronic Funds Transfers. Substantial amounts of money were transferred from savings for both parishes just to meet operational expenses. Families, yours and God's, need to bring in more resources than are spent. Funds in savings that are listed as Endowments or Trusts have restrictions upon their use, usually indicating that the principal amount of money cannot be utilized to meet expenses, only proceeds from them. Expenses for utilities and school subsidies declined while personnel expenditures increased. Although for this current fiscal year to balance the budget, staffing was decreased. Please devote some prayer in consideration of an increase in your contributions. Electronic Funds Transfer forms are available at our parish office and on our website. For convenience and an opportunity to earn perks, we also now include the option of donating via credit card on our parish website - click the "Donate" button on our homepage.




