Dear St. Joseph Parishioners,

There is a certain rhythm to life in a parish. While things tend to quiet down during the summer months, when September rolls around the parish begins to come back to life. This month, Religious Education classes are starting up again and people who spent the summer away have found their way back home. We continue to see people return following the pandemic. Saint Joseph Parish feels like it has come back to life.

Now we enter the month of October, the time when I write to ask for your support of the Grand Annual Collection. Every Sunday we take up the weekly Offertory Collection, our main source of income for the parish. In theory, the Offertory Collection should pay for all of our parish expenses. On the other hand, the Grand Annual Collection is intended to be used for capital improvements and for any unforeseen expenses that may arise. In reality, here at Saint Joseph as in many other parishes, the Grand Annual is also used to make up for any shortfall in the budget from the Offertory. Truthfully, we cannot pay for all our bills relying only on the Offertory. That has made the Grand Annual Collection incredibly important for our parish.

While we never know when unexpected expenses may arise, there is always the cost of maintaining what we have. In the current economic climate, the cost of simply running our facilities has increased significantly. Still, we would like to do more than just maintain; we would like to be able to make improvements to our facilities and to consider future projects. Earlier this year we installed heat pumps in the Parish Office thanks to a generous donation made by a parishioner. These heat pumps, which were also donated, have helped to drastically cut the cost of both heating and cooling our parish offices. Another generous donation last year allowed us to update the sound system in the church. Over the past three years we have spent more than \$100,000 on capital improvements around the church property. Your generosity has allowed us to make these necessary updates and we are truly grateful. There are still more projects we would like to undertake in the future. Last year I wrote of our desire to paint the inside of Saint Joseph Church. Unfortunately, the cost ended up being higher than anticipated and at the end of the day we just didn't have the funds. This is still a project that is needed and something I want to accomplish.

As a Parish Staff, we are attempting to do all we possibly can to make our parish run more efficiently. In the process of assembling this year's budget, we have taken a hard look at how we use the money that you, the parishioners of Saint Joseph so generously give to us. One result of this was the decision I made to consolidate the rectories of Saint Joseph and Saint Mary. In order to make better use of the funds allocated each year for the living expenses of the priests, both Fr. Antonio and I will live at the Saint Joseph Rectory. We estimate this one change alone will allow us to save approximately \$10,000.

I am well aware that this is a financially difficult time for so many. I recently read that it is estimated the average family spent approximately \$7,000 more this year to run their household. I am very grateful that during these recent difficult times you have continued to support Saint Joseph Parish. I

have been humbled time and again by the generosity of the Saint Joseph community. It is a very humbling experience for me to come to you asking for your continued support. I do so because I believe the upkeep and improvement of our Parish is important. All proceeds from the collection remain at St. Joseph's and contribute directly to the life of the parish. To achieve our goal of \$35,000, I would ask each family to consider a gift of \$300. This goal allows us to meet our operating needs and also begin the maintenance projects inside the church. I realize that for some families, this will be too great a sacrifice. Others will be able to give more. I am grateful for any amount that you are able to give. Saint Joseph is a special place and an important part of the Kingston community. The Grand Annual Collection is an investment that will help us continue to be a special place for many years to come.

One final note, I will speak briefly about our financial well-being as well as the Collaborative as a whole the weekend of **November 4th and 5th following all Masses**. This is an effort to be transparent about the financial condition and overall state of our Parish. Should you have any questions or thoughts, I would love to hear from you.
