Dear All,

In case you missed it last week, I am pretty strongly opposed to cultural and/or scientific movements to reduce human beings to some lesser common denominator. Last week I took on, pretty viciously, economic reductionism. In that school of thought, a discovered scarcity of resources makes humans a luxury that cannot be afforded. This reductionism allows those who have responsibility for the financial well-being of the relevant community – family, nation, world – to advocate and implement measures that will reduce the number of consumers in order to maximize the amount of money available for the fewer wealthy. But this is not the only form of reductionism to which *homo sapiens* (HS hereafter) is subject.

One that is particularly galling is what I call biological reductionism. There is no doubt that HS has a whole host of biological functions in common with other species of animals — everything from amoebae to zebras. In company with evolutionary thinkers, biological reductionists maintain that these similarities are all there is to know about HS. Any noticeable differences are attributed to differences in evolutionary tracks.

Two conclusions flow from this: every human behavior must have a biological explanation and a biological explanation only. Everything from societal life to prayer is to understood and explained, not as an advance of HS over some other life form, but just a mutation in the genome (genetic) or the environment (epigenetic). Second humans have no more control of or responsibility for their behavior than have cows or chimps. To maintain otherwise would be a form of *species-ism* akin to and fully as reprehensible as *racism*. The ultimate expression of this reduction is the proscription of any human activity that results in or depends on the death of any other life form – life is life, biology is biology.

The fallacy of this biological reductionism is clear; only humans, for no discernible biological reason, are actually able to choose to live non-competitively with each other and with only measured violence to the environment or its other denizens. We call this responsibility; and our treatment of the irresponsible we call justice or mercy – the latter is a reaction hardly visceral.

Against biological reductionism, Christianity proposes a unique *spiritual* dimension in HS that actually gives rise to a similarity between HS and a species, logically *post-human*, of beings who are neither determined nor limited

by biological factors. Those 'post-humans' (I have borrowed that term from the evolutionists) might be 'angels'; but they are certainly beings who more and

more closely (how many phyla of angels can fit in a chapter of metaphysics?) resemble the 'absolute Spirit' who is God.

We will look at other reductionisms as we go along and finally arrive at a truly Christian understanding of HS (we are still doing anthropology). But even if I were not a preacher, I would still owe it to you to point out the presuppositions on which the persuader class of our world rely.
