From the Pastor's Desk:

"Today, this scripture passage is fulfilled in your hearing." – Luke 4:21

We need to be aware that it's a continuation of last Sunday's Gospel where Jesus proclaimed that He is the Messiah and the fulfillment of all prophecies.

They were amazed at His teaching. Then they began to ask, "Who is this Jesus?" They looked at his family and place of birth. They wondered, "How can someone who looks like them and born in our locality claim to be above us and the prophets? How can He claim to be God or speak with such authority?" They were stuck in their human eyes and reasoning, which made them not accept Jesus or His message but rather reject Him and even try to kill Him.

Yes, in our lives too, we are often inspired by the Spirit, but then we turn the other way and go on living our lives. We don't want to accept the Invitation to transform our lives or ways. We create a facade of happiness and come up with reasonings and arguments against everything that is being offered to us by the Spirit.

Pray that we can be inspired by Jesus, who loves us, and His love never fails. The Holy Spirit may inspire us to believe in Jesus and be willing to accept Him as our Lord and Savior to the point of changing our ways and mending our lives. Be ready to become a new person in Jesus and a redeemed loving person.

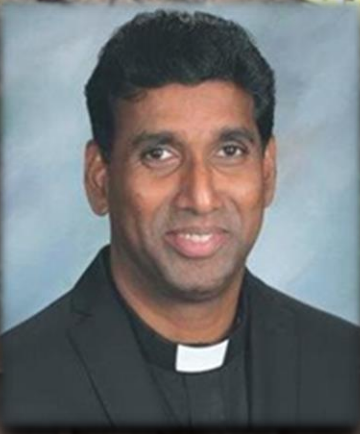

CONFIRMATION & FIRST HOLY COMMUNION: Please contact the Parish Office for more details.

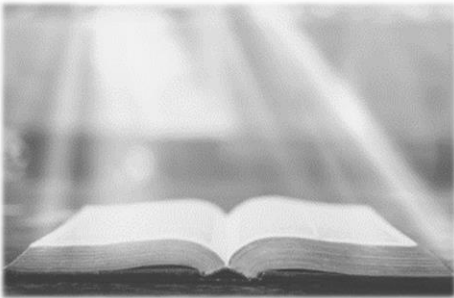
