### 5th Sunday of Lent



#### From the Pastor's Desk:

**"Let the one among you who is without sin be the first to throw a stone at her...  
Neither do I condemn you. Go, and sin no more". – John 8:7,11**

We are in the fifth Sunday of Lent, where we are invited to look deep into our lives and stop looking at others' lives and making excuses and justification for our own sins. God's mercy and forgiveness are available to all who admit and repent their own sins. God always has a compassionate heart for the sinner and provides all possibilities of repenting and returning to Him.

The woman caught in adultery is a sinner, and people wanted to punish both her and Jesus. They brought her to Him with a "two-edged sword" type of situation by asking Him to be Judge. If he punished her, He would be against the mercy that He preached and stood for. If He did not punish her, He would be against the authorities. Jesus did not fall into their trap. Jesus let them decide while directing to their own hearts and their own actions by saying, "let the one among you without sin be the first to throw a stone at her."

This is what the Holy Spirit does in the season of Lent. He directs us to our heart to see for ourselves if we are living a life worthy of the kingdom of God in all aspects and not in a selected or compartmentalized manner. The question for us is, "Are we sinners or saints?" When we recognize who we are, in all its authenticity and truth, God gives us the way to holiness. Our Merciful God is full of compassion and love for us. He invites us to the Sacrament of Reconciliation so we can change our lives and be pure and worthy of his love.

May Our Lady of Good Counsel intercede for us.

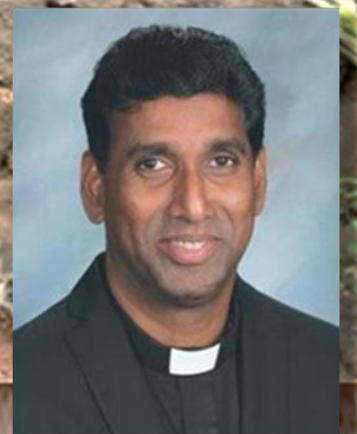

**CONFIRMATION & FIRST HOLY COMMUNION:** Please contact the Parish Office for more details.

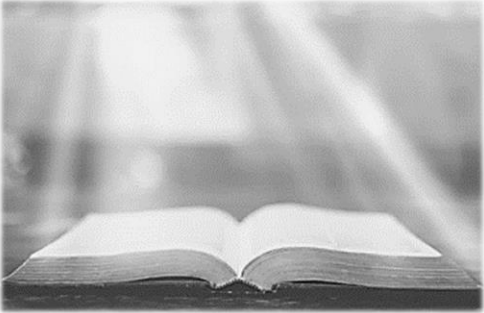
