Policy and Procedure for Streaming Weddings, Baptisms and Memorial Services

The Audio Visual Team ("AVT") of Mary, Mother of God Church (the "Church") will provide personnel and service to livestream weddings, baptisms and memorial services. A copy of the broadcast will be provided on a portable usb thumb drive or one provided by the person who is requesting a copy. The streaming service will use YouTube and a private link for the event will be provided to the <u>requestor</u> to give to family and friend so they may watch the event live.

This service is provided during the COVID-19 pandemic that restricts attendance at Church services. It allows family and friends to watch ceremonies that they cannot attend in person. The service is limited by the availability of AVT personnel to work the equipment. A month's notice is needed to schedule the service and set up the date on the Livestream site.

Live streaming will be limited to use of two church cameras (side and rear views). PowerPoint® presentations will not be used. One digital photograph (JPEG format, preferably using a width-to-height ratio of 16:9) to be displayed on the two screens in church prior to the ceremony. If the event will be published on the Church's Livestream website, this photograph will also be placed there for remote viewers to access.

There is no charge for the streaming service although the parishioner may make an offering to the Church in appreciation for the service.
