#### NATIONAL CHAPLAIN'S MESSAGE

## Spring Forth from Lent

he liturgical season of Lent coincides with spring, calling to mind the new life and growth, the hope and change that should characterize this time of prayer, fasting and almsgiving. This is likewise the season of initiation into the grace-life of the Church, when catechumens and inquirers more intensively prepare to receive the Sacraments of Initiation on

Easter Vigil. For forty days, the Church invites us to start afresh.

As I write this, I have just had the blessing of being the co-facilitator of the CDA Book Club we started this Lenten season, and Chapter II of this season's book by Pope Francis, A Gift of Joy and Hope, simply yet profoundly underscored the importance of slowing down, especially in this fast changing and extremely demanding world we are in today. Lent provides us with an opportunity to slow down and take stock of how well we are living our baptismal commitment as disciples of Christ; to reflect on our spiritual lives and to examine and deepen our relationships with God. The Church suggests that we focus on the traditional Lenten disciplines of prayer, fasting and almsgiving to renew our spiritual lives.

That's almost a nursery rhyme: prayer, fasting, almsgiving.

We repeatedly mention those words in our head, take them to heart, and commit to practice them with our hands, and we could potentially develop the habit.

And that, my dear Catholic daughters, is the key – repetition.

Recently, I was with our preschoolers here in my parish (I am super blessed to have a parochial school!), and I was invited to read a book for them after recess. The teacher gave me a book entitled *Green Eggs and Ham*, and immediately I thought it would be fun – *Green Eggs and Ham*. After all, they were all wearing green yesterday. Of course, I was wearing black!

I started reading, kids listening and interacting, and suddenly it hit. Kids start to learn how to read through coordinated sounds and repetitions. Every two or so pages, the sentence will end the same way: "I am Sam." Or "Sam I Am." (Sam is the name of the main character), and the preschoolers would excitedly join me each time, with joy building up as they all exclaimed "I am Sam!" Repetition is the tool in creating those memories in the young minds of these kids!

Repetition, but really it is intention. As adults (yet remaining kids at heart), we need to be intentional in our desire to pray, fast and give alms this Lent. We must be careful to pray, fast and give alms for the right intentions and not fall into self-serving measures, as it is easy for our Lenten fast to just become extensions of our New Year's resolutions.

This Jubilee of Hope, we are called to journey together, especially as we all gather together in the state level for our respective conventions this spring. In the language of the Eucharistic Revival which continues with another pilgrimage – this time from Indianapolis to Los Angeles starting May 18, and culminating on June 22, Corpus Christi Sunday – let us "walk with one." Let us continue walking with one another, in unity and charity, springing forward in hope and love!



#### Pope Leo XIV: The First U.S. Pope

Pope Leo XIV, born Robert Francis Prevost on September 14, 1955, in Chicago, Illinois, became the 267th pope of the Catholic Church on May 8, 2025. He is the first North American and the first Augustinian in centuries to hold the papacy. He is of French, Italian, and Spanish heritage. After earning a mathematics degree from Villanova University, he joined the Order of St. Augustine in 1978 and was ordained a priest in 1982. His missionary work in Peru, where he served as a parish pastor, seminary teacher, and diocesan official, significantly shaped his pastoral approach. He later became the Bishop of Chiclayo in 2015 and was appointed Prefect of the Dicastery for Bishops in 2023, choosing new Bishops and evaluating their performance for Pope Francis I.

He has chosen a very traditional name, Leo, which has been associated with some of the greatest Popes in history, including Pope Leo X, who commissioned the Sistine Chapel and led the church through the Protestant Reformation. Pope Leo XIII, the most recent to choose the name, was a reformist who was passionately committed to worker's rights and bringing the church into the modern era. Pope Leo XIV has emphasized themes of peace, unity, and spiritual guidance, addressing the Church's internal challenges and global issues such as climate change and social justice and is known for his humble demeanor and diplomatic skills. # cda membership in Action

s we continue to see the decrease in membership and retention within our organization, we must come to the realization that for Catholic Daughters of the Americas to survive, membership and retention must become a priority within our local courts and in our states. Assisting with increasing membership is the duty of every member. Do your local and state courts have a Membership and Development Team? If so, how active are they?

Let us take a moment to explore some ways that will help us to expand membership within our courts.

- First and foremost, include spiritual activities during all court meetings.
- The next thing is to establish a Membership and Development Team if your local court does not have one in place.
- Create a Referral Program. Have existing members recruit five new members. Establish a time frame. Think about giving some type of incentive to the existing members. Offer a gift card, a discount on dues, or even an entry into a drawing to win a prize.
- Host a Bring a Friend to a Meeting or CDA Event.
   Encourage members to think about a friend or relative who would benefit from or enjoy attending a meeting or an event of what CDA is all about. Their guests would have the opportunity to network and learn something new. By the conclusion of the meeting or event, they may become potential members.
- Create a Welcome Packet for guests. Include flyers such
  as the Top 10 Reasons to Join CDA, Unity and Charity,
  You are Invited to Join Us, and Spiritual Enhancement.
  The CDA store has these and other flyers that will be
  helpful. Take it one step further and include a couple of
  snacks or useful items.
- Contact former Catholic Daughters members who left for unknown reasons. Some might be ready to come back to the group. Mention the mission statement and highlight the benefits of their membership.

- Follow up with guests. Send a "Thank You" email or card or take it one step further and make a phone call. Recap the meeting and ask if they have any questions.
- Add a "Join Up Section" to your website. This is a good and effortless way to draw attention to anyone looking to join a local court. Utilize testimonials from members.
   If your local court does not have a website, now is the perfect time to consider establishing one for your court.
- Film members stories and testimonials about their experiences as Catholic Daughters. Publish them on your website to give potential members a visual look at the life of a Catholic Daughter. Ask members permission to share their stories.
- Update your website so that it is welcoming and easy to browse. Make sure the CDA Mission Statement is included on the first page.
- Host a charitable event in your local community or in town such as a Walk/Run. Introduce potential members to CDA while raising funds.
- **Hold diverse events.** Schedule events that will appeal to all age groups including young mothers.
- Host a guest speaker to attract non-members who share an interest in CDA. Speakers are powerful motivators.
   There is something in their message that might convince potential members to stick around to hear more about CDA from existing members.
- Arrange discussions about CDA and your local court with organizations in your parish and community. Make sure your topic is about the amazing works the Catholic Daughters are doing in the court, parish and in the community. Have CDA materials to pass out.
- When sponsoring or attending an event, include the name of your court and make sure the CDA Logo is visible on all materials. It does not hurt to leave your contact information. Have someone in the court make a couple of business cards when you know members are planning to attend an event not sponsored by CDA.
- Feature a member or two in the court's monthly or quarterly newsletter. Encourage members to share the newsletter with family, friends and even their colleagues if they are still employed. This will allow members to show off their involvement in CDA.
- Are your meetings leaving out existing members who work or those who are retired and go to bed early? Try switching up your meeting times so that more members will have an opportunity to attend.
- Be willing to experiment with new activities within the court.

  Ask members for suggestions. Make them feel included.
- Host seasonal Meet and Greets to include giveaways and fun activities.

# A Saint in Sneakers

wo things happened in 1991, one that changed the world of information as we know it and the other the birth of a saint who would use that change to spread devotion to his faith. Carlos Acutis used the first web search engine to share information about the Eucharist globally.

Carlos Acutis was born in London, England, on May 3, 1991. His baptism took place on May 18, 1991. A few months after his birth, the family moved to Milan, Italy, where he would live the rest of his short life. Neither of his parents were religious. His mother says that she had only attended Mass three times, at her first communion,

confirmation, and marriage. Her son would grow up and change all of that.

Even though his parents were not especially devout, Carlo had a special love for God from an early age. He also had a great love for Mary and prayed the Rosary every day. He made his First Holy Communion at age seven. Following that special day, he went to Mass and Adoration every day. He would drag his parents to church as often as he could. Carlo's love for the Eucharist also inspired a deep conversion in his mother.

He was an ordinary child who had an extraordinary love for

the Eucharist. He often said, "The Eucharist is my Highway to Heaven." He was deeply captivated by the miracles of the Eucharist and felt compelled to share them with the world. He used his computer skills and internet savvy to put together an exhibition on Eucharistic miracles that has gone on to be displayed at thousands of parishes around the world. His spiritual director has attested that Carlo was personally convinced that the scientific evidence from Eucharistic miracles would help people to realize that Jesus is truly present in the Eucharist and inspire them to come back to Mass. His

mother fondly remembers how the project became a family affair that lasted two and half years.

He told his mother one day that he couldn't understand why there were long lines at concert and football matches, but not for Eucharistic Adoration. The Eucharist was the center of his life, and he wanted it to be that way for others.

Carlo became friends with many of the homeless in Milan. He would often bring them food from home and stay to talk to them. He knew their names. He used his first allowance to buy a sleeping bag for a homeless man. He told his mom that he was fortunate to have everything he needed, and the man had nothing. So many of the homeless people that he touched went to his funeral to say goodbye.

He had many friends at school and on the soccer field. He was a faithful friend who always defended his faith. He was known for defending bullied kids, especially those with disabilities. He often spoke about the importance of going to Mass and confession, human dignity, and chastity with his friends.

Carlo told his mother that he was going to die young but not to worry about him because he would be in heaven with Jesus. Shortly before his passing, he recorded himself, stating that his life was coming to an end. In October 2006, he fell ill, and his parents believed he had the flu. When his symptoms worsened, he was taken to the hospital in Milan. There he was diagnosed with acute myeloid leukemia. He offered up his sufferings for Pope Benedict XVI, and the church in order that he may skip purgatory and go straight to Heaven. He died on October 12, 2006.

The church where his funeral service was held was described as overflowing with people he had helped throughout his short life, including the homeless people

whom he had befriended. He was buried in the village of Ternengo. His body was reburied in January 2007, in Assisi, which he had requested because of his devotion to St. Francis of Assisi.

The cause for Carlos's beatification and canonization opened in 2012, and received approval from the Holy See the following year. On July 5, 2018, he was declared "Venerable" by Pope Francis. The first miracle was attributed to him in early 2020, in response to a Brazilian boy born with a malformed pancreas having been healed after praying to Acutis for his intercession

and receiving one of his relics. He was formally beatified by Pope Francis on October 10, 2020.

In May 2024, Pope Francis recognized a second miracle that was attributed to Carlos's intercession. The miracle involved a 21-year-old woman from Costa Rica who fell from her bike, leaving her with a severe head trauma that doctors said she was not likely to survive. Her mother prayed to Blessed Carlos at his tomb. The next day, the young girl was sitting up and talking like nothing had happened. The doctors reported that the hemorrhage disappeared. Pope Francis would have canonized Blessed Carlos Acutis on Sunday, April 27, 2025. This also would have been the Jubilee Weekend for Teenagers and Divine Mercy Sunday. The date of his canonization will now be determined by our new pope.

For such a young man, he had a spiritual wisdom beyond his age. So many of his words are so inspiring for the young and not so young.

- "Mary is the only woman in my life."
- "To always be close to Jesus, that's my life plan."
- "All people are born as originals but many die as photocopies."
- "Continuously ask your guardian angel for help. Your guardian angel has to become your best friend."
- "Sadness is looking at ourselves, happiness is looking towards God."
- "I am happy to die because I have lived my life without wasting a minute on those things which do not please God."
- "By standing before the Eucharistic Christ, we become holy."

Blessed Carlos Acutis lived a short life that inspires and gives hope. Which quote above touches and inspires you? Will it change how you live? Will you seek the intercession of this new saint in sneakers?

#### CATHOLICS SEEK TO BRING A BRIGHT LIGHT TO

# History

n October 25, 2024, President Joe Biden did something no other United States President has done. He apologized to the American people for the federal government's involvement in Native American Boarding Schools. Under the guise of providing a "proper education and instilling in them American values," these federally funded schools were born. From 1860 until 1978, Native children were forced to attend these schools, whether the parents agreed or not.

The people in charge designed programs to eliminate Indian culture and traditions. Children could not speak their native languages. "Federal agents beat Native children in such schools for speaking Native languages, held them in unsanitary conditions, and forced them into manual and dangerous forms of labor," writes Maggie Blackhawk, Indigenous law professor. Statistics show that in 1926, there were over 61,000 Indigenous youth housed in facilities across the nation.

So, what does this despicable page in American History have to do with the Catholic Church? Well, our Catholic Church operated many of these schools. In fact, in June 2024, U.S. Catholic Bishops issued a public apology for the church's role in the administration of these institutions. They acknowledged the suffering and mistreatment of the innocent children who were forced to live there. However, apologies are not enough. Educating the public about the atrocities is imperative.

Congregations and religious orders across the states seek to bring justice and reconciliation for what amounts to acts of genocide (the systematic extermination of cultural groups). The National Native American Boarding School Healing Coalition (NABS) and the Catholic Truth & Healing organization continue to compile information on the Catholic-run schools. By studying the mistakes our predecessors made we can avoid duplicating these errors and move forward. Other groups are dedicated to addressing the abuse, neglect, and trauma that affected many communities in the United States. For example, together, the Archdiocese of Oklahoma City, the Diocese of



The Archdiocese of St. Paul and Minneapolis has an Office of Indian Ministry, which advances the relationship of the Catholic Church with the tribal groups in Minnesota. Robert Haarman, director of this office, reports a variety of community issues facing the survivors of the boarding schools, including "mental health, substance use/abuse, inadequate housing, family issues, and more." The faithful of these communities and those in other dioceses need to be informed about these issues. They need to follow their baptismal promise and meet the needs of those who have and are still suffering from the abuse.

involvement in it," Archbishop Coakley said. "We must

acknowledge the sufferings and disruptions entailed by

students, families, and tribes."

On January 9, 2025, the Washington State Catholic Conference (WSCC) commissioned its study of Catholic boarding schools in Washington. They join many other states to address the negative effects of the schools. Jean Hill, executive director of the WSCC, notes, "The study is a first step toward a more complete understanding of the Catholic Church in Washington state's relationship with local tribes related to boarding schools."

The Catholic Church was responsible for the suffering of so many young Native Americans. We cannot bury our heads in the sand and ignore the truth. We must encourage transparency and find ways to support healing. When the *Oklahoma Catholic Native Schools* project began, Bishop David A. Konderla of Tulsa said, "It is by understanding the past that we can improve and build on good ideas in the present and, where necessary, make amends for failures in the past." As Catholic Daughters, we, too, need to shed light on this dark period and assist in bringing healing and closure.



as anyone ever called you and said that they did not want to live any longer? What did you do? One of my friends was two and half hours from home when she received that call. During her trip back to Pine Bluff, she talked with her friend, saying, "Hey, wait a minute. I'm headed back right now." When she finally was able to see her friend face to face, her Mental Health First Aider Training saved the woman.

In 2001, an Australian nurse and a mental health professor developed Mental Health First Aider Training that is now a global movement with training in 24 countries. Based on the acronym, ALGEE, a stuffed Koala Bear named Algee is the Mental Health First Aider mascot. Many Mental Health First Aiders keep Algee with them as a reminder of the steps to diffuse a life-or-death crisis.


ALGEE represents the following:

- A Access risk of the situation. Call 911 if necessary or call 988 to speak to a trained Mental Health Provider 24 hours a day, 7 days a week.
- L Listen to the person in trouble because they called to be heard.
- G Give reassurance and support.
- E Encourage self-help.
- E Encourage professional help.

There are over 4 million trained Mental Health First Aiders in the United States. The goal is to have at least one person in a close circle of 15 friends, family, or peers trained. As a Mental Health First Aider, they can identify, understand, and respond to signs and symptoms of mental health and substance use. I've gone through the training twice. Some states require training every three years and some require it every two years.

Our CDA Quality of Life section of Circle of Love includes six pages of suggestions for programs and references. Did you know that Mental Health is not mentioned? Every day in every person's life, mental health is important. My challenge to each CDA Court is to Google your County University Extension Office and call them to see when the next Mental Health First Aider Training will be held. My hope is that you register and become a Mental Health First Aider.

If your CDA Court has several hundred members, do the Math to see how many Mental Health First Aiders you need for every 15 people. Training lasts 7.5 hours and may be free if a grant covers the cost. During this Year of Hope, Forbes reported that improving mental health was the number one resolution made by 45% of the people. Stay blessed as you add becoming a Mental Health First Aider to your goals.

Some of you can imagine the heartbreak of this mama. She feels she has failed her most important job, "To get her kids to heaven." She has felt guilt and wondered, "What could I have done differently?" Most of all, she spends every day in prayer for her children and grandchildren, asking the intercession of Saint Monica, the mother of Saint Augustine, to pray for her children to return to God. Dear member, continue with your beautiful faith and prayer. All in God's time.

Just like our member mentioned above, I have also experienced the heartbreak of longing for my children to connect with Mass. My husband and I have been married for 45 years. We have three children and six grandchildren. From

birth, our children were brought to Mass and received the sacraments. We were all involved in ministries and spent many hours both at church and outside of church with our parish friends. At the encouragement of our 17-yearold son, my husband converted to Catholicism. Our son is his godfather. About six months to a year later, our son no longer attended Mass. When he met his wife-to-be, he decided to marry in the church and has been attending Mass ever since. Our youngest daughter spent her last two years of college living on the college campus. When she returned home, we learned that







# **ARCHBISHOP FULTON J. SHEEN:** CONVERT MAKER



enerable Archbishop Fulton J. Sheen (1895-1979) was a larger-than-life priest of deep Catholic faith who had a special gift for connecting with all kinds of people. He is known for his radio show, his popular 1950s television show "Life is Worth Living," his many books and his teaching and preaching. Always impeccably dressed in the garb of the religious position he held, Sheen had the glitz and glamour of a celebrity priest.

But beneath that glamour was Sheen's deep commitment to Jesus, which translated into an ability to convert people to the Catholic faith - some of them unexpected and unlikely. Now on the path to sainthood, Sheen is credited with converting people as disparate as U.S. Congresswoman Clare Boothe Luce; Communist activist Louis Budenz; journalist Heywood Broun; spy Elizabeth Bentley; composer Fritz Kreisler; Communist Bella Dodd; Hollywood starlet Virginia Mayo; and many others. It is this ability to make converts that forms the foundation for this biography. Author Hughes, who holds a PhD in historical theology from Durham University in England, is clearly fascinated with Sheen's appeal to such diverse people in different walks of life.

The black and white photos in the book show a man with soulful eyes and a clear presence before the public. But there is one photo that I found especially moving. Sheen is bending over a leper from Uganda to give him a rosary. Sheen is clearly touching the man's whole hands - no dangling the rosary in the air to avoid skin contact. The archbishop was known to have a special concern for those with leprosy (Hanson's disease).

Born into a farming family that settled in Peoria, Illinois, Sheen decided early that farming was not for him. He was devout from an early age, becoming an altar boy at age eight. A graduate of his local boys' Catholic high school, Sheen excelled academically. After graduation from St. Viator College, Sheen became a



seminarian at St. Paul Seminary in Minnesota and was ordained to the priesthood in September of 1919. He was installed as the bishop of Rochester, N.Y., in December of 1966. In November 1969 Pope Paul VI named Sheen an archbishop.


I found all of the conversion stories compelling. Especially moving is the story of how Sheen rescued Clare Boothe Luce - magazine editor, playwright, war correspondent, Congresswoman, ambassador and advisor to presidents - from a suicidal depression following the death of her only child, Ann, in a car accident. Ann died on the scene when her car was hit near the campus of Stanford University, where she was a student.


Luce was getting ready to run for her second term in Congress at the time of Ann's death. "She was crying and trying to pray, but she had no words other than the Our Father," the author writes. A priest she knew said he would have Sheen, then a monsignor, call on her. Sheen invited her to his apartment for dinner, where he talked of the goodness of God. "Clare Luce recognized Sheen as the right catechist for her, and he knew she would be a good candidate for conversion," the book states. The two met frequently, and Luce found that she believed what the Catholic Church taught about Christ. She said she thanked God for "this brilliant teacher, this good and gifted professor of Catholic philosophy." She publicly wrote about her conversion for "McCall's" magazine.

Sheen's rise within the Catholic Church was not without conflict. The book does not white-wash the rift that developed between him and his mentor, Francis Cardinal Spellman. No doubt this caused Sheen much sorrow, but he was always respectful of Spellman and did not mention this falling out in his own autobiography.

The Bible shows us that God gives some men and women special gifts to serve Him. As this book makes clear, Venerable Fulton J. Sheen was one of those men. 🐺


