BANKRUPTCY FINAL REPORT

Bishop Gainor reported in his recent letter, earlier this month the bankruptcy court in Harrisburg approved a reorganization plan which resolves clerical abuse claims pending against the Diocese of Harrisburg and related parties. Parishes, including St Joseph Church, and other related parties also participated in the bankruptcy reorganization plan and will receive various legal and financial protections provided under the plan.

By participating in the reorganization process and making a relatively modest financial contribution to the plan, parishes of the Diocese, including St Joseph Church, have received immunity from all claims for events alleged to have occurred prior to the effective date of the Plan.

Importantly, the reorganization also provides for a multi-million dollar fund to provide monetary restitution, counseling and other services to the victims of clerical abuse. More details about the reorganization plan may be found in question & answer and bullet-point summaries posted on the parish website and available on the tables at the back of the Church and Parish Center.

Roman Catholic Diocese of Harrisburg Reorganization Plan Key Points

On Wednesday, February 15, 2023, the United States Bankruptcy Court for the Middle District of Pennsylvania approved the Joint Plan of Reorganization for the *Roman Catholic Diocese of Harrisburg*. This Plan establishes how the *RCDH* will satisfy the claims filed against it, how it will emerge from bankruptcy, and how it will operate as an organization going forward. Through this Plan, the RCDH is renewing its pledge and commitment to assist abuse survivors, and its commitment to foster spiritual growth and pursue the mission of the Church in central Pennsylvania

- The Diocese settled 111 claims, totaling \$12,784,450, through the independent Survivor Compensation Program. Some abuse survivors chose not to participate and/or accept settlement offers. Further, with an ever-increasing number of lawsuits, to bring about some closure and finality, while providing financial support for as many survivors as possible, would be to do so under a Chapter 11 reorganization.
- The RCDH filed for reorganization on February 19, 2020. A month later, the courts, businesses, schools, churches, etc. were closed for in person operations due to the COVID-19 virus. The pandemic played a significant role in delaying this process.
- The Plan outlines how the RCDH and related entities will (a) establish a Survivor Compensation Trust, (b) provide funding to the Trust in an amount equal to \$7,500,000 to provide financial restitution for survivors of clergy sexual abuse, and (c) adopt enhanced child protection protocols. The financial restitution from the RCDH and related entities, insurance providers will also contribute \$10,750,000 to the Trust. The Plan also includes details on how the RCDH will operate moving forward and modifications to our Youth Protection policies.
- The RCDH intends to use proceeds from the sale of unused land, interest/dividends from our investments, proceeds from cost saving initiatives and contributions from the Ad Hoc Committee to pay for these settlements.
- The RCDH cannot take money given to the parishes to pay its portion of the settlement. The RCDH must fulfill its financial obligations included in the settlement by living within its means. In order to protect the parishes and Catholic schools from any potential future liability, our pastors are independently participating in an Ad Hoc Committee and will be contributing a portion to the Trust. By participating in the Committee and contributing, our parishes, Catholic schools, and certain other related third-party entities, will be granted immunity from potential future costly legal actions.
- The Diocesan Annual Campaign monies are contributions designated for the purposes, ministries and mission outlined in the annual Campaign materials. This includes support for our spiritual and educational ministries and programs, Catholic schools, Catholic Charities, and vocations. The materials for the Annual Campaign specifically state that no gifts will be used to satisfy legal fees or settlement costs associated with clergy sexual abuse and this includes the costs associated with the RCDH reorganization. The same is true for the other special collections of the Diocese, including the Pentecost Collection, Matthew 25, and the Catholic Communications Collection. All of these collections are designated for specific programs or specific purposes.
- The Diocese and Ad Hoc Committee will provide their portions of the Trust funding by March, 2023. The parishes, Catholic schools, and certain other related third-party entities are all separate legal entities; however, they were invited to participate in an Ad Hoc Committee during the reorganization process. On their own, the pastors and leadership of these groups entered into the Committee and offered to make a voluntary contribution toward the overall settlement. Through this contribution, all of these entities will be granted immunity from all potential claims/legal actions for past offenses.
- More than 60 proofs of claim were submitted during the reorganization process and may be eligible for financial distributions from the Survivor Compensation Trust.
- Through the reorganization process, the Diocese was able to bring finality to all historic or pre-existing claims against it that may have occurred prior to February 19, 2020. While we will continue to pray and support abuse survivors, as outlined in the Plan, these claims are now finalized and the Diocese can move forward with a renewed focus on its works of ministry, charity and evangelization.
- The Roman Catholic Diocese of Harrisburg is committed to providing a safe environment for all children and vulnerable adults. Since 2002, the RCDH has had policies and procedures in place to ensure, as much as reasonably possible, that children are safe. Education, training and safe environment programs, stringent policies and procedures, and an annual audit of all youth protection efforts have been in place for decades. And pursuant to the Plan, the RCDH is adopting enhanced policies and procedures to better protect our youth.
