#### MINUTES OF REGULAR MEETING OF THE BOARD OF DIRECTORS OF HEADWATERS MUNICIPAL UTILITY DISTRICT OF HAYS COUNTY Thursday, April 15, 2021

The Board of Directors of Headwaters Municipal Utility District of Hays County (the "District") held a regular meeting, open to the public, commencing at 12:00 p.m. on Thursday, April 15, 2021. In accordance with the Governor's emergency proclamation suspending certain provisions of the Texas Open Meetings Act effective March 16, 2020 in response to COVID-19 pandemic, notice of the meeting provided information for all persons, including members of the public, to join and participate in the meeting by telephone or by weblink.

The roll was called of the directors of the Board, to-wit:

and all directors were present except Director Marlow, thus constituting a quorum.

Also present were Miki Martin from Malone Wheeler, Inc.; Mike Morin from Crossroads Utility Services; Matt Matthews from Freehold Capital Management; Taylor Kolmodin from Municipal Accounts & Consulting, Inc.; David Allen from Allen Engineering Group; Blake Rue of Oryx Land Holdings, LLC; Garry Kimball of Specialized Public Finance, Inc; and Anthony S. Corbett and Lauren Hughes of McLean & Howard, L.L.P.

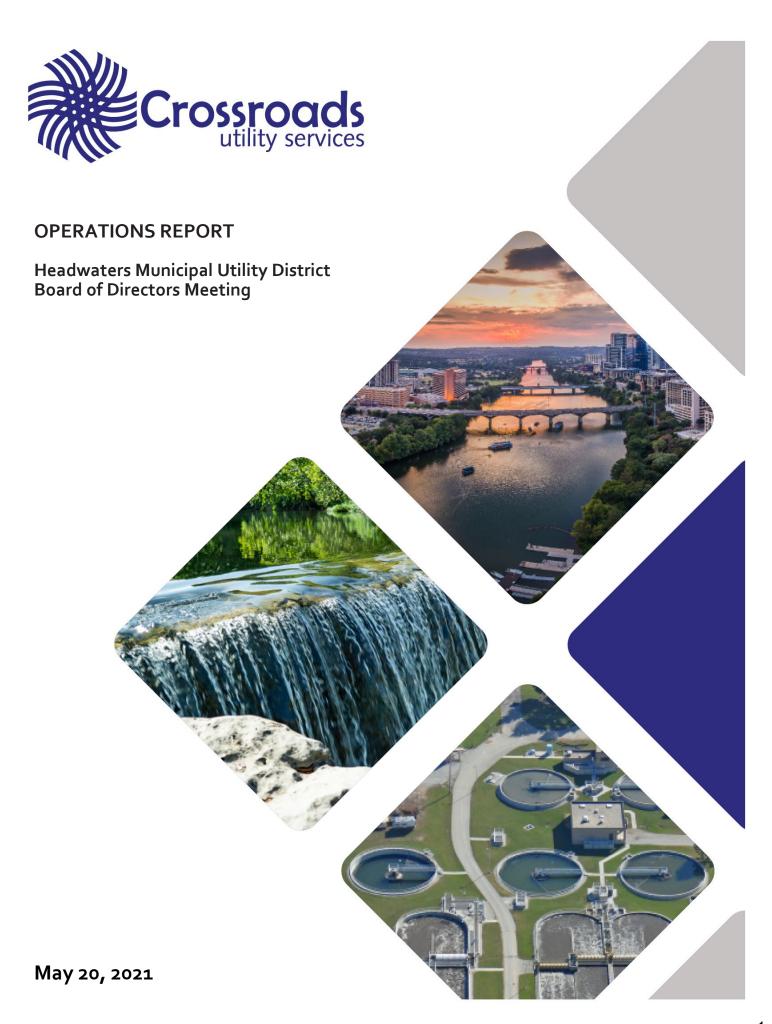
- 1. The Board first considered public comment. No public comment was received.
- 2. The next item to come before the Board was approval of the minutes of the Board's March 18, 2021 meeting. Upon a motion made by Director Zinn, Jr., that was seconded by Director Jacks, the Board unanimously approved the meeting minutes as presented (4-0).
- 3. The Board then received the monthly operations report. Mr. Morin summarized monthly utility operations and services. A copy of the written Operations Report prepared by Crossroads Utility Services, L.L.C., is attached as an exhibit to these meeting minutes. David Allen presented his monthly report regarding wastewater treatment plant and effluent disposal operations.

- 4. The Board then considered the Engineer's Report. Ms. Martin presented a report to the Board and summarized the status of engineering and construction activities within the District. She stated that the developer of the Headwaters Office West Project requested authorization to proceed with bidding for the public infrastructure improvements related to the project. Director Jacks made a motion to authorize bidding to proceed for the Headwaters Office West Project. Director Farrell seconded the motion, which the Board passed unanimously (4-0). A copy of the written Engineer's Report is attached as an exhibit to these minutes.
- 5. Next, the Board considered the Consent to Partial Assignment of Bond Proceeds by WFC Headwaters Owner VII, L.P. to Oryx Land Holdings, L.L.C. for Wastewater Phase 2 Expansion Costs previously funded by Oryx Land Holdings, L.L.C. Mr. Corbett explained the purposes of the assignment and reimbursement rights to be assigned thereunder. After discussion, Director Jacks made a motion to approve the Consent to Partial Assignment of Bond Proceeds as presented. Director Farrell seconded the motion, which the Board passed unanimously (4-0). A copy of the Consent is attached as an exhibit to these minutes.
- 6. The Board considered matters relating to the proposed issuance of Headwaters Municipal Utility District of Hays County Unlimited Tax Bonds, Series 2021. Mr. Kimball presented a report to the Board regarding the proposed issuance of the next series of road bonds, and regarding the issuance of the first series of utility bonds to fund an expansion to the District's wastewater treatment and disposal facilities. After discussion, Director Farrell made a motion to authorize an application to City of Dripping Springs to secure its consent to the issuance of both series of bonds. Director Jacks seconded the motion, which the Board passed unanimously (4-0).
- 7. Director Zinn, Jr., made a motion to authorize Jones-Heroy & Associates, Inc., to prepare the Bond Application to Texas Commission on Environmental Quality for authorization to issue the utility bonds. Director Jacks seconded the motion, which the Board passed unanimously 45-0).
- 8. Director Stephens made a motion to approve the engagement of West Davis & Company for preparation of Agreed Upon Procedures Report relating to disbursement of bond proceeds and calculation of developer interest with respect to the proposed issuance of utility bonds. Director Jacks seconded the motion, which the Board passed unanimously (4-0). A copy of the engagement letter is attached as an exhibit to these minutes.
- 9. Director Zinn, Jr., then moved that the Board authorize such other action as may be necessary to proceed with the sale and issuance of the road bonds and utility bonds. Director Stephens seconded the motion, which the Board passed unanimously (4-0).
- 10. Matt D. Matthews provided a report to the Board regarding the status of construction, development and home sale activities within the single-family residential development lands of the District. The Board took no action regarding the report.
- 11. Mr. Rue provided a brief report regarding the status of development activities within the commercial lands. The Board took no action in response to the report.

12.	Ms. Taylor then presented the Bookkeeper's Report. Director Jacks moved that the
Board approv	ve the payment of bills and invoices as presented in the Bookkeepers Report and two
additional ch	necks (Check Nos. 10532 and 10533). The motion was seconded by Director Farrel
and passed u	unanimously (4-0). Copies of the bookkeepers' report and the approved bills and
invoices are	attached as exhibits to these minutes.

There being no further business to come before the Board, by unanimous acclamation, the meeting adjourned at approximately 12:25 p.m.

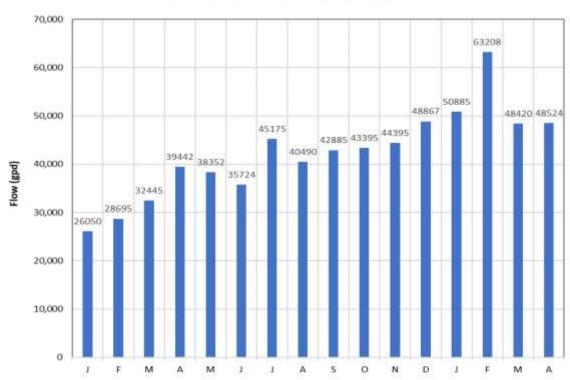

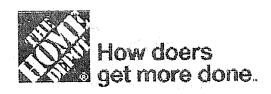

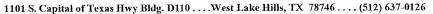

The events of Winter Storm Uri between February 14<sup>th</sup> and 23<sup>rd</sup> were unprecedented in their damage to utilities in the Austin area. The events that ultimately transpired due to power outages and extreme weather were true tests of our operational responsiveness and commitment as a utility service company to our valued clients. In many ways, our staff individually rose to the challenge set before them and corporately came together to triage issues and accomplish tasks to fix, maintain and restore the most basic form of service to our clients. We are very proud of our team and our coordinated response to this disaster and look forward to enhancing our exemplary service and implementing lessons we have learned from this event.

As with many utilities required to immediately respond to this disaster, we experienced several business expenses that we have reviewed and submitted within a single service order per District. These expenses have been categorized by functional unit within our business and allocated as a percentage based on the size of each individual client's connection count. Due to the disaster's effect on the support side of our company, many of the hours and expenses we have paid and reimbursed our staff were not able to be individually delineated on separate orders and charged to a single client. Our business office, which coordinates over 500 service tickets and 2,200 calls on a normal week, remained closed due to the freezing temperatures and electricity reliability during the height of the storm event.

We hope summarizing and allocating expenses during this storm event is straightforward. We believe we did our best to capture expenses related to this event in a fair and reasonable manner. 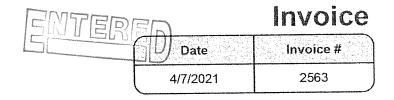

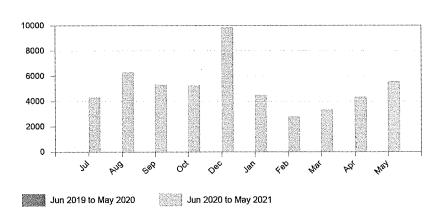
