**Office and salaries:** includes telephone, internet. photocopier maintenance, computer expenses. Salaries include employer portion of CPP and EI

Liturgical, education: Liturgical expenses, staff and volunteer education expenses

Other: Items for resale, candles, GST expense, fundraising expenses
