# **Baptismal Preparation**

We at St. Elizabeth Ann Seton are happy that you want to have your baby baptized. The baptism of your child provides an opportunity for your entire family to reflect on a faith-filled life and spirituality. In bringing your child to the Church to receive this Sacrament, you are saying that you desire to share your living faith with your child. This is a step you are taking to raise your child within the community of believers and to educate them in the Catholic faith.

# First Steps

- 1. Download and fill out a baptismal registration form.
- 2. Return the completed form to the parish office with a copy of your child's birth certificate.
- 3. At this time, you will have the opportunity to sign up for a baptismal class on our website.
- 4. Upon completion of the class the Baptism of your child can be scheduled.

# Age of Child

Under ordinary circumstances, parents should see to the baptism of their infants within the first few weeks/months. The first consideration in determining the time is the welfare of the child. If the child is sickly, the baptism should not be unduly delayed.

If your child is seven years or older, we will work with you to find the best pathway that leads your child to the Sacrament of Baptism.

### Membership

When you call the parish office at SEAS or come in to talk to us about the baptism of your child, we will look and see if **a.**) you are registered in the parish and **b.**) you practice your faith. If you are not registered, now is the time to register! Once your family is registered, then we ask that you begin your journey to baptism.

Although the Sacrament of Baptism does not have a cost for parishioners, the day of the Baptism you will have the opportunity to make a donation to the church.

#### Non-Members

However, there are always special cases, and for good reasons, we are happy to work with non-members to provide the Sacraments of the Church to their children. In the case of non-members, we ask for a letter of permission and delegation from the pastor of their home parish.

# **Baptismal Preparation Classes**

It is necessary that both parents attend a baptism class if this is their first child being baptized. If both parents have attended a baptismal preparation class within the last 5 years, we would welcome their participation but do not require that they attend again.

You may attend classes online or at a neighboring parish. Please check their class schedules. A letter of verification of attendance from that church is required.

### **Requirements for Parents**

At least one of the parents should be a practicing Catholic willing to commit to the task of rearing their child in the faith of the Church. Parents should accept that they are the first and foremost teachers of the faith.

Often times the baptism of the child encourages the parents to participate fully in the practice and living of their faith. The birth of the child and the desire to have that child baptized serves as a catalyst for the parents to return to a faith filled life within the Catholic community.

# Requirements for Godparents/Sponsors

Godparents need to be actively emerged in the Catholic tradition. They serve as models and guides in the life of the child and the parents. They, along with the priest and parents, welcome the child to the community and signify that welcome by marking the child with the Sign of the Cross. Godparents promise to support the parents in raising the child in the practice of the faith.

Choosing a godparent/sponsor is a very personal decision, however, the Church does ask that certain requirements be met:

- At least 16 years of age.
- A practicing Catholic who is baptized and confirmed and has received First Communion.
- Someone other than the parents of the child to be baptized.
- Leading a life in harmony with the Catholic faith and the role they are about to assume.

Note: Only one godparent/sponsor is required. As long as one of the godparents is a practicing Catholic, a baptized practicing non-Catholic Christian may serve as a "Christian Witness" as a second sponsor to the baptism. A Christian Witness is not required to take the baptismal preparation class, but they are welcome to attend.

# Godparents

Congratulations! You have been asked to be a Godparent/sponsor. The role of a Godparent/sponsor is more than merely ceremonial. It is a ministry and a responsibility. A godparent/sponsor stands for the Church and this representation must manifest an authenticity.

- The Church has requirements that must be fulfilled to act as a Godparent/sponsor. However, the first question is not whether the Church will permit you to be a Godparent/sponsor, but whether you can allow yourself to be one! Can you honestly say you live your faith and model Christ-like living?
- Each one of us must ask, "Does my integrity allow me to stand at the altar and make a public profession that the faith I proclaim in Word is truly a faith that I practice?"
- The role of Godparent/sponsor does not demand that we be a saint, and all of us have need of God's mercy as we travel on our Christian faith journey. It often happens that we are asked to act as a Godparent/sponsor even though we may not be actively practicing our faith. Family members or friends sometimes feel compelled to ask you because of tradition, unaware that you no longer practice your Catholic faith.
- If you are in this situation, we invite you to grow in your faith and uphold your integrity. You could sit down with a priest, deacon, or a practicing Catholic family member or friend who can help you take a new path in your faith.
- Perhaps you are not ready for this honor and new responsibility. If you cannot bring yourself to a renewed practice of faith, then please be honest enough to simply ask your relative or friend to excuse you because you are not able to fulfill this role properly. This is what is meant by a Call to Integrity.
- If we can be of any assistance in your decision or in helping you respond to the grace that this occasion provides you, please contact us. A request to be a Godparent/sponsor can be a graced-filled moment inviting you to turn again to Christ. Every child deserves and needs a good role model.

Remember the issue here is not whether you are a good person with high moral values, but whether you **practice the Catholic faith in accordance with the basic requirements listed below.** To be Catholic you must be involved in worship and the sacramental life of the Catholic Church.
