# As We Gather

## **Please Observe Our Guidelines**

#### **Reduced Capacity**

No ticketing or reservations are required to attend Mass. However, due to the layout of our church and the need to accommodate physical distancing, the reduced capacity required of gatherings may be reached for any of the scheduled Masses. We are prepared to welcome worshippers at an overflow Mass in either Caulfield Hall or Christopher Hall (gym) should the need arise at any of the scheduled Masses. Please follow the directions of the ushers to an overflow Mass.

## **Hand Sanitizer**

All members of the assembly are to sanitize their hands upon entering church. Hand sanitizer is available at all entrances to church. Use of restrooms should be limited in order to reduce the need to continually sanitize high contact areas. All water fountains are out-of-order until further notice.

#### Wear Masks

Face-coverings/masks are required to be worn in and around the church, except by children ages two and under.

#### Stay 6 Feet Apart

Maintain physical distancing in the parking lot and as you enter and leave church. Every other row is open for seating. Other than immediate family members in a household, worshippers should be seated six feet apart, following the round stickers on the backs of the pews.

#### Holy Wate

The baptismal font and holy water stoups will remain empty until further notice.

#### No Hymnals

The hymnals have been removed from the pews. The readings and music for Mass will be available in a printed Order of Worship. When you leave Mass, dispose of the program in one of the designated trash cans at the entrances.

#### **No Offertory Collection**

The offering envelopes have been removed from the pews. Baskets are available for your offerings as you enter and leave the nave of church.

# No Sign of Peace

The celebrant will offer the invitation for the Sign of Peace and the congregation will reply as usual. Any physical and/or verbal exchange of peace with other worshippers is omitted until further notice.

## **Holy Communion**

Please follow the directions of the ushers and floor markings for routes to receive Communion. Only hosts will be distributed for Communion and will be distributed in the hand.

# Organization Highlights

#### ST. MARTIN'S CLOAK

- ♦ Distributed \$9,118 to individuals/organizations serving the poor.
- Prior to pandemic, distributed bread and food products to Missionaries of Charity, SOME and two seminaries.
- Served meals at Shepherd's Table, then prepared over 8,000 sandwiches per month.

#### **SODALITY**

- ♦ Advent Giving Tree provided 897 gifts to 18 organizations. Sodality spent \$2,782 to complete some organizational gifts.
- ♦ Donated \$6,500 to parish and Archdiocesan food assistance programs.
- ♦ Tithed \$3,900 to the parish.
- Former 8th grader and Junior Sodalist Katie McCabe, winner of the 2020 Junior Sodality scholarship essay contest, was awarded a \$2,500 scholarship toward her tuition at Georgetown Visitation Preparatory School.

#### **LADIES OF CHARITY**

Prior to the pandemic, provided weekly communion service to residents at Bethesda Health and Rehabilitation Center, where there is an average of 28 Catholic residents. Some non-Catholic residents also attended Catholic services that included monthly Mass celebrated by a parish priest.

## **HOME & SCHOOL ASSOCIATION**

- Provided \$40,000 to fund 180 new Chromebooks as well as document cameras.
- Spent \$18,615 for gifts for teachers and staff.

# **CATHOLIC YOUTH ORGANIZATION (CYO)**

• Fall and early winter sports programs were the only operational CYO activities for children age pre-K to 12th grade (school and parish) due to the Covid-19 restrictions.

**Poor Box**: Is designated each week for a specific local charity.

#### **IRA Charitable Distribution:**

If you are aged 70 ½ or older, you can transfer up to \$100,000 each year directly from your traditional IRA account to St. Jane Frances de Chantal Parish. This smarter way to give may satisfy a portion or all of your annual required minimum distribution (RMD) and serve as a qualified charitable distribution for your IRA, which can save you on taxes even if you do not itemize! Contact your plan custodian to complete the IRA transfer. For IRA charitable distribution checks, please make sure the check stub lists the "donor" name and the fund the distribution should benefit (e.g., offertory, donation, St. Martin's Cloak, etc.).
