MESSAGE FROM OUR PASTOR:

I am pleased to present to you the Financial Statement for the fiscal year 2019-2020 and the report on ministries for the Parish of the Holy Eucharist. The grip of the pandemic affected all our families and by extension, our parish. We went almost three months without public masses and have a reduced attendance at mass since June 1st.

I am grateful for your generosity in this time of great turmoil. Several parishioners enrolled in the WeShare online giving program and many others have been faithful in mailing in their offertory gifts to ensure we had a cash flow. Other parishioners exercised their stewardship by making masks for us to use, bringing food to the priests, donating flowers for the Churches, and other acts of kindness.

Our dedicated staff worked diligently to offer many virtual opportunities for parishioners to remain connected with each other and to grow in the faith. We exercised our stewardship by monitoring expenses closely. We also took the slow down in public functions to begin an evaluation of our facilities, and when possible, to perform some preventive maintenance to avoid future higher costs.

You will note that we have proposed a bold budget for the coming year. This reflects our belief that the Parish of the Holy Eucharist must remain in the forefront of offering hope, faith and assistance in the face of this ongoing pandemic. Our efforts may look very different than previously but are no less needed. We must also look to make upgrades to our equipment and facilities to meet the new demands of a pandemic society. I know that I can continue to trust in your generosity and prayer. Our Finance Committee chairperson, Stephen Mitchell, will offer some specific insights into the financial statement. Please feel free to reach out to either of us if you have any questions.

MESSAGE FROM STEVE MITCHELL, FINANCE CHAIR:

First, on behalf of the Finance Council, thank you for your continued support of our Parish as we work to fulfill our mission through pastoral care, ministries, and programs.



The past fiscal year was like no other, and it presented many challenges as the pandemic progressed. With your support, we are rising to meet this challenge. However, pressures were evident in our fiscal 2020 results, which showed an operating loss for the year, and these pressures continue in the current fiscal year.

I want to note a few significant items in the statements:

- 2019 Operating Income reflected the generous response to our campaign to increase our offertory. While 2020
 income reflects the impacts of the pandemic, we are looking to see 2021 levels of support return to pre-COVID
 levels.
- There were two notable events that impacted our balance sheet. The first was the receipt of two bequests during the past fiscal year that are captured in Capital Campaign Savings.
- The second change to our balance sheet resulted not from new activity, but from a change in presentation of financials that was adopted across the diocese. With this change, our balance sheet now displays funds held by the Catholic Foundation of Maine, which are held for our benefit. These amounts are displayed in Assets Held by the Catholic Foundation of Maine.

Once again, I want to thank you for your support. The Finance Council works closely with our Pastor, Fr. Phil, and our Business Manager, Melissa Bagdon, to assist them in providing strong stewardship of the treasure you share. Please reach out to me or any member of the council with any questions you may have, and please take care of yourself and others during these times.

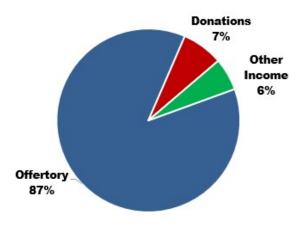

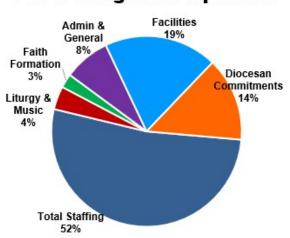

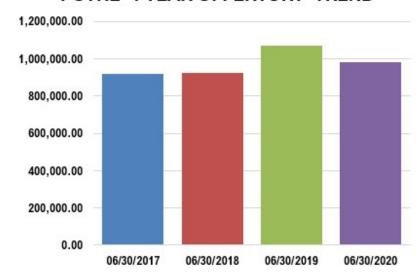
2021 Budgeted Revenue

ANNUAL REPORT OF MINISTRIES

For Fiscal Year July 1, 2019 — June 30, 2020

SACRAMENTAL MINISTRY

The sacraments are efficacious signs of grace, instituted by Christ and entrusted to the Church, by which divine life is dispensed to us. During this past year, the Parish of the Holy Eucharist, conferred these signs of grace as follows:

We welcomed 76 new families for a total of 201 new members who joined our parish during the last year!

SOCIAL JUSTICE COMMISSION MINISTRY

- A total of \$71,209 was distributed for the 2019/2020 fiscal year.
 All funds for parish charitable work are donated by our generous parishioners and distributed through the Haiti and Needy Funds
- Haiti support totaling \$26,000 was sent to our sister parishes in Haiti: \$12,200 to St. Therese of the Child Jesus in Marbial & \$13,600 to Parish of Sacre-Coeur church and parish center.
- Parish assistance—\$45,209 was distributed through both the holiday programs listed below and in response to 56 requests for general assistance and 16 requests for heating assistance
- Ongoing support to local food pantries & service organizations in each community. Habitat for Humanity Good Friday Walk & Maine Right to Life Mother's Day flower donations were sadly not held this year due to the pandemic, but we hope they may return in the upcoming year.

HOLIDAY/FEAST DAY PROJECTS

- Thanksgiving—68 families or individuals received food baskets; gift cards for food purchases were offered to 32 families; 119 bags of donated groceries and \$355 were given to pantries
- Christmas—hundreds of gifts, numerous gift cards, as well as food baskets were given to local families, and organizations serving youth, veterans, religious sisters, and the aging
- Easter—\$1,200 was used to purchase gift cards for 32 families

FORMATION MINISTRY

- 218 students took part in Faith Formation sessions for children ages 5 to 18 during the 2019/2020 school year
- 21 campers, 14 youth volunteers, & 10 adult volunteers took part in Vacation Bible Camp July 2020
- Making Music Praying Twice served 24 families with 45 children
- That Man Is You weekly meetings at Sacred Heart
- Aging with Grace Focus Groups & Symposiums on End -of-Life Issues and Catholic Social Teaching
- 130 parishioners and 28 facilitators participated in Small Faith Sharing groups: The Wild Goose, Presence: The Mystery of the Eucharist
- RCIA—2 adult confirmed and received first Eucharist, and 4 teens confirmed

DEVOTIONAL MINISTRY

- Parishioners were nourished by active prayer life including the Rosary, Adoration of the Holy Eucharist, Centering Prayer, Liturgy of the Hours, Opus Dei, ACTS, and blessing of animals
- Divine Mercy Sunday Prayer Service was held at Holy Martyrs
- Crowning of Mary on Mother's Day
- Sacred Heart Church provided a sacred space for both Tenebrae and Lessons and Carol services.
- Parishioners participated in *Lord Teach me to Pray* and 33 Days to Morning Glory
- Hour of Power was held monthly at St. Jude

CATHOLIC APPEAL

382 families contributed a total of \$307,953

CATHOLIC SCHOOLS

We provided \$21,850.00 to students attending Catholic Schools in the 2019 to 2020 school year—13 in grammar school and 6 in high school.

PASTORAL MINISTRY

- Parishioners were active in nursing home and home bound ministry, taking communion to Catholics who are unable to join us at Mass (until the current pandemic)
- Weekly support meetings for Alzheimer caregivers at Sacred Heart
- Grief support meetings held twice a month at Sacred Heart
- Annual Masses to remember our deceased and veterans
- Monthly free senior lunches and other events at Sacred Heart through Aging with Grace
- Open Heart Open Doors Ministry for Special Needs through a grant from Catholic Charities
