### FAMILY FAITH FORMATION

#### The Sacraments of Vocation

This week’s *Family Faith Formation* topic is “The Sacraments of Vocation,” covering Questions 218-221, 226-228 in *The Apostolate’s Family Catechism*. Home Lesson packets are available on the parish website and also in your email (if you registered for FFF).

#### By-Heart Catechism

**218. What is the Sacrament of Holy Orders?** This Sacrament makes certain baptized men particularly like Christ the High Priest, entrusting them with a ministry of special service in and for the Church and providing them with sacred power to fulfill this ministry. The three ranks of Holy Orders are: bishop, priest, deacon.

**221. What can priests do as representatives of Jesus Christ?** As *alter Christus* (Latin for “another Christ”), priests act *in persona Christi capitis* (“in the person of Christ the Head”) by offering the Sacrifice of the Mass, administering the Sacrament of Reconciliation to penitents, and administering the Sacrament of Anointing of the Sick to those in need of it. They also baptize, witness a Church marriage, and bury the dead (all of which deacons also can do).

**226. Who instituted marriage?** God did in the Garden of Eden, creating humans to be male and female and commanding them to “be fruitful and multiply.” Jesus elevated the relationship of marriage to the dignity of Sacrament (the Sacrament of Holy Matrimony) at the Wedding Feast of Cana (Jn 2:1-11).

**228. Who are the ministers of Holy Matrimony?** The couple themselves are the ministers of Holy Matrimony; the bishop, priest, or deacon are merely the Church’s official witnesses of the Sacrament as it begins during the wedding rite.

Sacrament of Holy Matrimony: Couples contact Rev. Jeffrey Lewis at least four months prior to marriage.

### Faithful Citizenship: Subsidiarity

It is impossible to promote the dignity of the person without showing concern for the family, groups, associations, local territorial realities — in short, for that aggregate of economic, social, cultural, sports-oriented, recreational, professional, and political expressions to which people spontaneously give life and which make it possible for them to achieve effective social growth.

The human person is not only sacred but also social. Full human development takes place in relationship with others. The family (based on marriage between one man and one woman) is the first and fundamental unit of society and is a sanctuary for the creation and nurturing of children. It should be defended and strengthened, not redefined, undermined, or further distorted. Respect for the family should be reflected in every policy and program. It is important to uphold parents’ rights and responsibilities to care for their children, including the right to choose their children’s education.

How we organize our society (in economics and politics, in law and policy) directly affects the common good and the capacity of individuals to develop their full potential. Every person and association has a right and a duty to participate actively in shaping society and to promote the well-being of all, especially the poor and vulnerable. The principle of subsidiarity reminds us that larger institutions in society should not overwhelm or interfere with smaller or local institutions, yet larger institutions have essential responsibilities when the more local institutions cannot adequately protect human dignity, meet human needs, and advance the common good.

In American politics, this means that it is normal and preferable for the federal government to refrain from meddling in matters properly dealing with local state-level, county-level, and city-level matters; the federal government cannot and must not try telling the City of Chewelah that the speed limit on Main Avenue must be 50 mph.

In the Catholic Church, it is perhaps a little-known fact (but a fact nonetheless) that the Vatican must refrain from meddling in diocesan-level and parish-level affairs. Pope Francis cannot tell Bishop Daly that the Diocese of Spokane must forbid the Extraordinary Form of the Mass (the so-called “Latin Mass”), for that is Bishop Daly’s decision; similarly, Bishop Daly cannot tell me, as duly-appointed pastor here in Stevens County, that I must have a Sunday Mass at 6 AM, for that is my decision to make as pastor. These are political and ecclesial examples of the principle of subsidiarity. The general rule of thumb is this: if a matter must be dealt with or a decision must be made, preference and pride of place must be given to the simplest, smallest, most local level of authority and then progress upward and outward from there *only* as needed.

Next week, we reflect upon the principle of solidarity.
