NOTICE OF MEETING



Notice is hereby given pursuant to Texas Government Code, Chapter 551, that the Board of Directors of Lakeside Water Control and Improvement District No. 2C will hold a regular meeting, open to the public, on April 8, 2025, at 5:45 p.m., outside the boundaries of the District, at 21100 Carries Ranch Road, Pflugerville, Texas, for the following purposes:

1. Call meeting to order and establish quorum;
2. Discuss, consider, and take action to approve minutes of March 11, 2025 regular meeting;
3. Receive public comment (three (3) minutes per speaker; but any person providing public comment through a translator is limited to six (6) minutes, unless the District uses simultaneous translation equipment in a manner that allows the Board to hear the translated public testimony simultaneously with the speaker);
4. Receive report from District's Engineer and discuss, consider, and take action regarding the same, including, but not limited to:
 - A. Change Order No. 1 and Pay Application No. 4 for Blackhawk Amenity Center Tennis Court Project, submitted by AO Services; and
 - B. Carlson, Brigance & Doering, Inc. invoice for construction administration;
5. Receive operations report from Crossroads Utility Services and discuss, consider, and take action regarding the same;
6. Receive recreational facilities report and take action as necessary concerning the same, including, but not limited to, maintenance and/or improvements to existing recreational facilities;
7. Discuss, consider, and take action on payment of invoices and bookkeeper's report;
8. Discuss, consider, and take action as necessary concerning Utility Services Agreement between Lakeside WCID No. 2C and Trails at Blackhawk Condominium Community, Inc.;
9. The Board will meet in executive session to receive advice from its attorney regarding Utility Services Agreement between Lakeside WCID No. 2C and Trails at Blackhawk Condominium Community, Inc., in accordance with Texas Government Code § 551.071;
10. Receive update on 2025 Legislative Session;
