 - a. Maintain stormwater website(s) to ensure that the public can easily find information about the SWMP, and to inform citizens about steps that can be taken to improve water quality and prevent stormwater pollution;

- b. Post announcements regarding Stormwater Committee meetings and other stormwater-related information on the Districts' stormwater website(s);
 - c. Post information on procedures for the appropriate disposal of various waste materials to the Districts' stormwater website(s);
 - d. Post information regarding the discharge of landscaping and lawn care waste to the Districts' stormwater website(s);
 - e. Develop and maintain a mechanism to receive and consider information provided by the public regarding construction site stormwater runoff and illegal dumping;
 - f. Complete inspections of 100% of outfalls that discharge to the Districts' MS4s;
 - g. Coordinate with neighboring MS4s to participate in public events to educate the public on stormwater pollution and prevention;
 - h. Share information on litter collection, illegal dumping activities, pollutants of concern, and/or the Districts' contractors' use of pesticides, insecticides, herbicides, fungicides, and/or rodenticides with interested, neighboring MS4s;
 - i. Implement rules for construction activity within the Districts' collective MS4 boundaries and coordinate with neighboring MS4s and/or the TCEQ for enforcement assistance;
 - j. Develop and provide educational materials for school children concerning stormwater-related issues to local schools;
 - k. Conduct an annual review of reporting hotlines and websites currently made available by coalition members and make any necessary updates; and
 - l. Conduct an annual review of reporting phone numbers and websites and make any necessary updates.
