



Sunday, November 14, 2021

¹ Nativity records depreciation (a non-cash expense) for future capital repairs and replacement. FY 2021 depreciation totaled \$613,787.

Note: Due to the large financial operation, Nativity, by the request of the Pastor, Trustees, and Finance Council, undertakes a fully accredited audit each year. This report is based on this year's audit. The financial statement includes revenues and expenses as it relates to parish operations. Nativity reports on a full accrual basis; therefore, we recognize revenues and expenses at the time they were earned and incurred.

he financial statements for Nativity of Our Lord for the fiscal year ending June 30, 2021 reflect a net operating loss of \$394,264. This includes all operating cash items (revenue, operating, and capital expenses and capital expenditures) incurred during the same 2021 fiscal year.

Despite the enormous challenges from the COVID pandemic, we experienced a decrease of only 1.4% in reported operating revenue compared to the prior year with the envelope and plate collection decreasing a relatively modest 5.3%. This collection revenue funds our ministries and pays for the daily operating expenses of the parish. We are most grateful for the generosity of our community during this trying period.

We completed the external tuckpointing project this year, which totaled \$539,558, representing the largest portion of our capital expenditures. The most significant expense of repairs on the interior of the church, however, still lie ahead. The plastic sheeting on the east interior wall remains in place to capture debris as the wall continues to dry out over the next several months, to allow for the major (and costly) interior repairs to begin.

These construction costs were largely paid for by the generous donations from current parishioners and estate gifts. Prudent management of past gifts has built up allocated cash reserves, which will be drawn down as we address the significant capital improvements which are necessary on our campus.

The balance sheet above shows the historical generosity of our parishioners, which has allowed us to prudently build up reserves over the years to ensure the sustainability of One Nativity. Some of these funds are restricted to specific uses by donors or the board, while others are earmarked as operating reserves.

The largest portion is dedicated to a long-term capital spending plan being developed for the parish through a thoughtful process. We are committed to ensuring the maintenance and preservation of Nativity's beautiful buildings while continually addressing the needs of our parish and school.

Maintaining the current levels of reserves in the bank allows the parish to comfortably navigate the various ups and downs of the economy, such as the COVID pandemic, as well as the ongoing facility repairs and maintenance, with a sense of confidence.

We are excited and proud to share the news that during the 2021 fiscal year, a Scholarship Endowment Fund was established. This fund is now perpetually endowed for the exclusive purpose of tuition assistance for educational programming of the One Nativity community. The assets of the Parish Endowment Fund and the Scholarship Endowment Fund are managed by the Catholic Community Foundation of Minnesota.

We are Called to Greatness through Faith and Service!

his year's theme provides our school community with a purpose centered on Christ and how we can best live out our mission to develop the best version of ourselves. Greatness can only be achieved through service of others with a joyful heart.

This year, we are committed to reestablishing many opportunities and experiences for our students that embody the best Nativity has to offer. Engaged learning experiences, enrichment opportunities, and academic support offerings help each of our students strive to reach their academic potential.

The hard work by our students last spring and this summer yielded a positive result in this fall's standardized testing (NWEA MAP Test for grades 3-8). Having our students on campus last year for in-person learning contributed to their academic achievement and success at year end and as we began the new school year. The average score by grade level as compared to students across the nation are listed below. Congratulations Nativity students!

Our new Director of Curriculum and Instruction, Mrs. Tami Lodge, former middle school science teacher, will continue to work with our teachers to analyze these results, along with the other assessments which reflect our daily standards-based instruction, to help all students grow academically.

The work happening in our classrooms is reinforced through field trips, classroom presentations, athletics, and after -school programming. Our seventh graders just returned from a three-day environmental camp experience in Lanesboro, MN— an important annual event that was missed last year due to the pandemic. Our kindergarteners have been to the farm at Dodge Nature Center, first graders have been to Afton Apple Orchard, the second graders to the State Capitol, and the fifth grade even went to Target Field for a creative mathbased field trip! Each step taken is a step back to the normal learning experiences offered at Nativity as we learn to navigate our way through the impact of COVID-19. We are grateful!

We look forward to reinstating many service and leadership experiences for our students this year. Our Student Council will

coordinate school-wide service experiences like our on-going relationship with Holy Rosary Parish with our Thanksgiving and Christmas donation drives. We are looking forward to two Family Service Mornings this year — one during the season of Advent and the other during Lent. We hope to reestablish our Backpacks of Love program that serves local families in need with staple food items each week which is sponsored by our school children. Finally, our Social Justice Club in the middle school is up and running and seeking ways that they can make a positive impact in the world around them!

Our enrollment grew this year as we welcomed several new families to Nativity School. Each child brings their own unique set of gifts and talents to our community which only makes our community stronger. We also welcomed a new assistant principal, Mr. Andy Jacobson, and five new teachers to our staff, two of which are alumni of Nativity! The future continues to look bright at Nativity School thanks to the generosity of prayer and financial support of our parishioners.

As we know, last year brought challenges to the Nativity Early Learning Center, including low enrollment and staff shortages. The COVID-19 pandemic has affected us both financially and operationally. We were extremely lucky and blessed to receive COVID-19 Public Health Support Funds through the Minnesota Department of Human Services, which helped to keep our doors open. We felt it was important to stay open, despite the risk, to support the needs of working families in our community. This year, our preschool enrollment is still not at full capacity, but we have seen a rise in school-age afterschool care.

The NELC is nestled in the heart of Nativity's parish and school, occupying the two lower levels of the Lannan Center at 1900 Wellesley Ave, directly across the street from Nativity School. The NELC has an excellent full-day preschool program, extended day afterschool program for children in grades K-5, as well as a summer camp program with convenient hours with long-term, knowledgeable, dedicated, and loving teachers.
