2 Agenda Item name: Financials review

Summary of discussion

- November collections of \$103K, \$5K lower than LY but \$11K better than plan.
 YTD revenues are in line with LY and \$26K higher than plan
- Noted that 46% of collections are automated via ACH and card payments, while the rest are cash and check. This is high for the archdiocese, but it leaves room for improvement to reduce volatility
- November professional fees were elevated due to building / grounds study and partial payment for CPA review. Expect December and potentially January will be similarly elevated before returning to normal
- Completed information provision to Clifton Larson in November. Audit team completing reviews and expect to share report in January
- Have higher cash position than LY. Receivables balances higher than LY due to late start with some tuition billing
- Construction loan paid down to \$2.0MM. We are not making any prepayments at the moment, just paying \$18K / month on the normal schedule
