All about the experience

When Ron & Bonnie Schneider decided to send their daughters, Sarah ('85) and Becky ('89), to Lourdes Academy for high school, they did it for a number of reasons. These reasons included faith-based education, small class sizes, student-teacher relationships and ultimately a great overall experience during pivotal years of their daughters' lives.

Sarah was quick to point out how Lourdes kept impacting her life after graduation and at UW-Stout.

Schneider has enjoyed a successful career in retail merchandising and management, including the past 15 years at School Specialty. She began as a merchandise manager and currently finds herself as a merchandise team leader while living in Green Bay.

Although Schneider's mind was set on starting a career in retail merchandising and management after graduating from UW-Stout, her experience at Lourdes gave her the drive to stay committed to her goal.

"I was already motivated in what I wanted to do with my career," Schneider said. "That motivation came from the confidence I was able to build during my time at Lourdes."

Along with gaining self confidence, Schneider believes

there is a true family atmosphere at Lourdes Academy that separates the graduates from other school communities.

She was quick to name the countless teachers and staff that dedicated themselves to Lourdes Academy and helped her grow as a student and overall person.

"There is always someone at Lourdes looking out for you," Schneider said. "Teachers were always looking out for kids, and parents were looking out for each other's kids along the way. It is hard to explain if you have friends that grew up in a public school atmosphere only because they never experienced it."

This Lourdes experience was the biggest motivator to give back to Lourdes, and she has done so annually for the past two decades. Schneider is hoping her gifts to Lourdes Academy will help get the next generation of graduates ready for life after high school.

"I just wanted to help other kids get that same experience," Schneider said. "I know my donations are going to the right place. Hopefully, I am helping other kids and teachers."

At first, Schneider wanted to make a difference in the lives of the students. Throughout her career, she realized there was another crucial group of people at Lourdes she believed in and wanted to help.

"Since starting my job at School Specialty and being there for almost 15 years, I have learned that being a teacher is not all that easy," Schneider said. "Having the right tools for teachers is tough and expensive. However, it is very important."

Schneider was able to reconnect with many former classmates at the UKnighted4Life All-Class Reunion last June. She enjoyed touring the new campus while comparing what life at Lourdes was like in 1985. Whenever Schneider finds herself back in Oshkosh, she always thinks of the great memories and life-long friendships she created at Lourdes Academy.

"Every time I think about Lourdes, it makes me happy," Schneider said. "When I am visiting family in Oshkosh and drive by Lourdes, it just makes me happy. It is a great place."

They try to show it in as many ways as they are able. This admiration stems back to Michelle's time at Lourdes. Transitioning from public school to Lourdes went seamlessly and Michelle felt a special bond at Lourdes.

"(My transition to Lourdes) was very similar to what I hear now, and that is everyone was really welcoming," Michelle said.

That welcoming feeling never vanished. In fact, it only grew into a familial place.

"I think that's part of the reason why we wanted our kids to go to Lourdes now is because it just always felt like a family."

The family quickly became even more important once their daughters, Kayla ('27), Avianna ('29) and Brielle ('37), were enrolled at Lourdes.

Michelle and Tony both agree that volunteering is a crucial part of the Lourdes experience. Their involvement started with commitment to various committees and both serving on the Board of Trustees at separate times.

"We have been blessed in a lot of ways," Michelle said. "Whether it is based on our finances or our

backgrounds, we feel it is our obligation to give back to our community because we want our community to be a good place to live in. With our kids being at Lourdes, that is our main community right now so we want to see the school succeed."

That commitment quickly expanded to other volunteer roles throughout the system, including coaching basketball, after school activities and substitute teaching. The Wihlm's time commitment only strengthens the Lourdes family. They have embraced the sense of community and the importance of getting to know everyone that contributes to Lourdes.

"Volunteering allows you to have more conversations with other adults and get to know some of my kids' friends' parents better. The more you know your community, the safer and stronger your community is."

Tony was quick to realize the impact it had not only on the parents around them, but other children in the system, as well.

"What I have noticed the most is, the kids love having the parents involved," Tony said. "That surprised me. They love seeing you at games. Whether sporting events, a musical or whatever it may be, they enjoy seeing other parents at events."

At the end of the day, Tony and Michelle will continue to better the Lourdes community, mainly due to their faith.

"When you volunteer and take time off from your job, you are sacrificing money and valuable time away from your career," Tony said. "You need to outweigh the benefits of that and realize it is what your faith wants you to do."

A lasting honor



The Dorothy & Robert Isom MD Family Endowment Fund benefits teachers in the Lourdes Academy system.

At first, Mary Nolte (Isom-'80) knew she wanted to give back to Lourdes in her parents' memory but was unsure how to do so.

After her father, Robert, passed away in 2016, Mary's mother and Robert's wife, Dorothy, made mention of Lourdes when thinking of organizations to receive charitable donations in lieu of flowers. Nolte kept that thought in the back of her head until Dorothy passed away in 2021.

"Lourdes Academy was always near and dear to my parents' hearts," Nolte said.

That love for Lourdes was on full display when Dorothy moved into Evergreen Retirement Community before her passing. Dorothy met other Lourdes supporters living at Evergreen, including past Lourdes auction co-chairpersons. Nolte could see the joy it brought her mother to relive those Lourdes memories.

When it came time, Nolte thought back to how much Lourdes meant to her parents and began the process of setting up an endowment fund with Director of Advancement Karen Boehm.

Boehm led Nolte on a tour of the Lourdes campus, leaving her impressed. However, Mary was still unsure

how she wanted to set up the funds within Lourdes Academy. That was until the light bulb went on during her drive home after the tour. Nolte started thinking about the importance of teachers, especially those in Catholic education. She wanted to ease the burden on the faculty due to how they impact Lourdes Academy on a daily basis, and do it in her parents' honor. Mary and her husband, Tom Nolte, understand the importance of Catholic education and the opportunities it offered their two sons. They also realize the hardships teachers may face.

"Having put our own children through Catholic education in Milwaukee, we are more than aware of how much out-of-pocket expenses there can be in teaching," Mary said. "Teaching at a Catholic school almost becomes a vocation because they feel called to do this. They don't think much about what they make in terms of money but instead on how they are changing kids' lives every day."

Nolte continued the process with Boehm and the Dorothy & Robert Isom MD Family Endowment Fund was established in 2022. Mary's siblings, Lori ('78) and Jeff ('83), who are both in the education field, readily agreed to the plan. They were excited about finding a way to support faculty members from their alma mater.

Nolte was quick to compliment Boehm for how smoothly everything went.

"The process with Karen was enjoyable," Nolte said. "I truly felt that I made a friend in Karen. She is wonderful to work with."

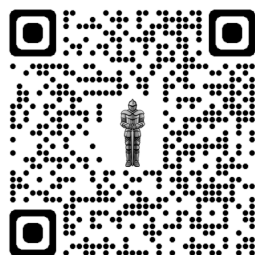
