President's Report:

- A. John attended the Oshkosh Economic Breakfast an annual event held at the Convention Center where guest speaker gives a presentation on the 2025 economic outlook. This year's speaker has appeared on Fox News, CNN and others.

 - A goal is to maintain our cash reserve balance as much as possible.
 - The proposed budget consists of essential needs only and paring it back any further would hinder our ability to operate up to our own expected standards.
 - o Discussion held on some budget items.

 - b. On Tuesday, a guest speaker gave a presentation to the students on social media/artificial intelligence and the digital foot print that students make and how that could impact their college and scholarship applications.
 - c. Seussical the Musical practices are in full swing. The performance is three weeks away and tickets are now on sale.
 - d. Literary Club and Chem Club officers met today.
 - e. A normal weekly mass will be held tomorrow.
 - f. Winter sports teams are finishing their regular season.
- C. Parish Representative Communication
 - a. Tina Wickham noted that St. Mary, Omro is hosting a speaker, Mr. Peace, with his program theme is Bullying: Look at the Heart First. This is a free event and everyone is encouraged to attend. Please share this information with Lourdes students. It's a free event and open to all ages.
 - b. The St. Mary, Omro youth are in the planning stages for a Peru mission trip.
