### **Approval of Agenda:**

Dave Hetzel motioned to approve the May 21, 2025 agenda. Dcn. Rick seconded the motion. The motion carried.

### **Approval of Minutes:**

#### **President's Report:**

# **Official Action:**

- Dave Hetzel motioned to approve new policy 5085-3<sup>rd</sup> to 4<sup>th</sup> grade promotion. This policy is a requirement of the new Act 20 mandate regarding literacy practices particularly for students in 4K through 3<sup>rd</sup> grade. It focuses on ensuring all students achieve reading proficiency entering 4<sup>th</sup> grade by implementing science-aligned literacy instruction, regular screening and diagnostic assessments, and teacher preparation. The motion to accept was seconded by Dcn. Rick. The motion passed.
- Bart Pritzl motion to approve the proposed updated policy 5028-Dress Code which summarizes the requirements of a dress code. Tina Wickham seconded the motion. Motion was approved.

## **Reports and Communications:**

- A. Lourdes Academy Foundation Report
  - a. Karen reported that at the last Foundation meeting, Karlene Grabner gave a presentation on fund performance over time for funds at the Oshkosh Area Community Foundation.
  - b. A capital campaign update was given.
  - c. Discussion was held on how to keep the Foundation viable with expenses exceeding income. One way is to move from an annual compilation of funds versus an annual review of funding. A motion was made to make this change and the motion was approved. That will be the direction of the Foundation for FY 6/30/2025.
