Message From Bishop LaValley

How Does the Reorganization Case Affect Our Parish?

The Diocese of Ogdensburg filed a reorganization case under Chapter 11 of the U.S. Bankruptcy Code in order, seeking to resolve the lawsuits that have been filed under the Child Victims Act in a fair and orderly manner. In New York State, our parish is a corporation separate and distinct from the diocese. Our parish has not filed for bankruptcy protection. However, it is hoped that the reorganization case will resolve all claims against the diocese, parishes, and related entities. It is likely that our parish will be asked to contribute funds to settle these claims so we can be free of litigation in state courts and released from all liability for existing claims. It is hoped that the reorganization case will have minimal impact on the celebration of sacraments, programs, and activities in our parish. Please pray for a timely and fair resolution of pending lawsuits, and a renewed commitment to proclaiming the Gospel in the North Country.
