RESOLUTION NO. 19-01

A RESOLUTION of the Board of Commissioners of Vashon-Maury Island Park & Recreation District (aka Vashon Park District), King County, Washington, providing for the submission to the voters of the District at a special election to be held therein on April 23, 2019 of a proposition authorizing a property tax levy to be made annually for 4 years commencing in 2019, for collection in 2020 through 2023, the proceeds of such levy to be used to pay operation and maintenance costs associated with the District's facilities, all as more particularly set forth herein.

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF VASHON PARK DISTRICT, KING COUNTY, WASHINGTON, as follows:

Section 1. Recitals and Findings. The Board of Commissioners (the "Board") of Vashon Park District, King County, Washington (the "District") makes the following findings and determinations:

1.1 In order to provide the funds required to meet District operation and maintenance expenses in 2020 through 2023 (inclusive), the Board determines that it is necessary to submit to the voters for their approval pursuant to RCW 36.69.145, a ballot proposition to impose a property tax levy to be made annually in each of 4 consecutive years, beginning with a levy made in 2019 for collection in 2020.

Section 2. Calling of Election. The Board requests that the Auditor of King County (the "Auditor") call and conduct a special election in the District in the manner and during the hours provided by law in conjunction with the statewide general election to be held on November 5, 2019. The purpose of the election is to seek voter approval for a regular property tax levy as authorized by RCW 36.69.145 and as described in this resolution. If approved by the requisite number of voters, the District will be authorized to levy a regular property tax, in each year for 4 consecutive years beginning with taxes payable in 2020, at a rate not to exceed 52 cents per \$1,000 of assessed value.

Section 3. Use of Levy Proceeds. The funds will be used for District purposes and to meet District expenses during calendar years 2020 through 2023, inclusive. The levy amount will be used for operating and maintaining District facilities.

Section 4. Ballot Proposition; Submission to County. The Secretary of the Board is authorized and directed to certify to the Director of Elections, as ex officio supervisor of elections in the District, a copy of this resolution and the proposition to be submitted at that election in the form of ballot title, which (pursuant to 29A.36.210), the County Prosecuting Attorney in substantially the following form:

Section 5. Voter's Pamphlet. For the purposes of participating in a special election April 23, 2019, the Vashon Park District will be participating in the voters' pamphlet. Resolution 19-01 of the Vashon Park District requests voters' pamphlet publication.

Section 6. Authorization; Effective Date. The Secretary of the Board and other proper District officials are directed to perform such other duties as are necessary or required by law to the end that the question as provided for in this resolution shall be submitted to the voters of the District. This resolution shall be in full force and effect from and after its adoption. All actions taken prior to the effective date of this resolution and not inconsistent with the provisions of this resolution are hereby and in all respects ratified, approved and confirmed.

Passage of Proposition 1 would authorize the Vashon-Maury Island Park and Recreation District (Vashon Park District) to levy annually for four years excess property taxes to pay costs for operation and maintenance associated with the District's facilities. This levy will replace the District's expiring levy.

The proposed four-year Maintenance and Operations Levy would authorize the collection of levy amounts estimated to be \$0.52 per \$1,000 of assessed value in each of the years between 2020 and 2023. The tax rate of approximately \$0.52 per \$1,000 of assessed value projected for the first year of collection in 2020 would equate to \$52.00 per year (or \$4.33 per month) for a \$100,000 home.

Exemptions from taxes may be available to homeowners who are 61 or older, or disabled, and who meet certain income requirements. For more information, call the king County Department of Assessments at 206-296-7300.
