Overview

For over 13 years, Vashon Adventures (formerly Vashon Watersports and Vashon E-Bike) have provided human powered, outdoor adventures for islanders and visitors alike. Our mission-encourage people of all ages and skill levels to explore and appreciate Vashon Island in an ecofriendly way.

Now, after more than a decade of growth and community building, we are ready to pass the torch. Our goal is to maintain community access to paddling, camping, and youth programming while ensuring the business continues to flourish under new stewardship.

Accomplishments & Highlights

- **Fleet Growth:** Expanded to accommodate over 60 paddlers at a time with high-quality kayaks, paddleboards, and safety gear.
- **Digital Infrastructure:** Custom online reservation and waiver system, POS, and inventory management.
- **Youth & Community Engagement:** Paddle camps, skills classes, and programming with schools and nonprofits such as Vashon Nature Center, Vashon Wilderness Program, Vashon School District and the Low Tide Celebration.
- **Tourism & Marketing:** Active promotion of Vashon through Adventure Cycling, Washington Water Trails, and regional tourism groups.
- **Event Hosting:** Customized large-group activities for weddings, retreats, and community celebrations.
- **Primitive Camping:** Collaborated with King County Parks to develop primitive camping and assisted Vashon Park District in reservation requirements for Lisabeula and Pt Robinson camping.

Vashon Adventures is a proven, community-loved, and profitable outdoor recreation business with both physical and digital infrastructure fully in place. **This turn-key operation is being offered to the Vashon Park District for \$50,000.**

Below is a breakdown of the physical and business assets offered to Vashon Park District. The physical asset cost is based on our experience of selling used gear and does not reflect the replacement cost if purchasing wholesale- that price would be at least double the proposed price.

Physical Assets (Price \$41,600)

The fleet was designed to offer high quality kayaks and paddleboards for any skill level, those with mobility challenges and to encourage family paddling.

- Tandem Kayaks (15)
- Stand Up Paddleboards (18)
- Safety Gear (including PFDs, paddle floats and bilge pumps)
- Paddles for kayaks and paddleboards
- Spray Skirts

To optimize daily operations, a golf cart was customized to reduce the number of employees needed to move vessels. A robust point of sale system was implemented for online and walk-in customers.

Financial Report

We have included our 2025 Profit and Loss statement through September 3rd. The camping sales have not been updated and are accurate through August 31, 2025. Since Vashon Adventures is an LLC and a small independent business, some of the expense categories would not be representative for a larger operation, such as the park district.

We have also included the requested 3year comparison of revenue and net income specific to the watersports and camping components of Vashon Adventures.
