## PHASED RE-OPENING PLAN

JGS School, in collaboration with the LDOE, the Diocese of Shreveport, local health officials and administrators, has worked diligently to develop a school re-opening plan that allows students to return to campus in a manner that reduces health related risks while maintaining an environment conducive to educating the whole child.



High Risk: 100% Virtual Learning

All instruction and support provided to students remotely. Chromebooks provided as needed for distance learning. Attendance required through daily participation and completion of online assignments.

PHASE 2 *JGS School is currently operating in Phase 2 in accordance with state and local guidelines.* 

Moderate Risk: School will begin on August 24 with a full day for all students and face-to-face instruction. A Virtual Learning Option will be available via livestream with JGS teachers to any student due to health concerns or if required to quarantine. Temperature checks will be required on arrival to school with hand sanitizing on entry. Masks required on entry/exit and transition for grades 3-6. Desks will be spaced to social distance and dividers used where necessary with assigned seating to limit exposure. Classes will remain in static groups of no more than 25, including teacher, with activity teachers traveling to classes to limit transitions. A hand sanitizing/washing routine will be required frequently throughout the school day. Sanitizing high touch surfaces will be required hourly. Social distancing will be required in all common areas including hallways and bathrooms. School lunch will be provided and students will eat with their static group in the classroom. Microwaves and water fountains will not be available. Students are required to bring a labeled, refillable water bottle to school, preferably with a screw-off top with a retractable mouthpiece or straw. Students will have recess as a static group and playground equipment will be disinfected between groups. Visitors and volunteers will not be permitted on campus during school hours. If a student must check-in/out, the parent should remain in their vehicle and call the school office. Large gatherings will not be permitted on school property during phase 2. School Masses will follow the protocol set forth by Bishop Malone and the Diocese of Shreveport.

## PHASE 3

*Mild Risk*: Students will attend school with face-to-face instruction daily. The virtual learning option will remain available to any student. School will operate normally with continued enhanced sanitizing, social distancing and continued mitigation measures.



JGS School will provide virtual and on-campus learning with the necessary campus and classroom modifications needed to support students' safe return to school this fall. For the virtual learning option, students will be required to participate with his/her class via livestream for the entirety of the academic school day. Chromebooks will be available to students in grades 1-6 who choose to participate in the virtual learning option.



This plan may be updated regularly based on the guidance of local and state health officials. JGS School will share updated information through all communication channels provided by the school. Please stay connected through text, Rams email, Facebook, Instagram and Twitter regarding infection levels, policy changes and other important news.



Parents should report any suspected, presumptive or positive Covid-19 cases within the household to the school administrator immediately. JGS School will honor the privacy of our school families while implementing advanced safety measures. In the case of a positive Covid-19 test within a particular classroom, we may require that all students within the classroom move to the distance learning model for 14 days.
