Ryves Youth Center at Etling Hall served 658 youth in activities such as sports, scouting, preschool, nutritious meals, tutoring, reading and backpack distribution. Ryves Youth Center offers crisis intervention, afternoon snacks and evening meals, full-day preschool, tutoring, Scouts, organized sports, music program, mentoring and computer training in our computer lab. Breakfast, lunch and an evening meal are served to the preschool for homeless and at-risk children and an evening meal is served to the children participating in the afternoon programs. All of our meals and programs are provided at no financial charge.

4b (Code:) (Expenses \$ 271,364 including grants of \$ 11,410) (Revenue \$)

Bethany House emergency shelter provides temporary shelter for single women, married couples and families. The 43 adults and 14 children received case management, referrals and skills development. The Clothes Closet provided gently used clothing and small household items to over 12,000 people including residents in the shelter and the community at-large.

The Christmas Store provided new gifts to 457 low-income families. Additional items such as furniture and kitchen items are provided to low-income families, victims of fires or home invasions and families transitioning from a shelter to permanent housing.
