A Message from Fr. Scott: Chronic Budgeted Deficits Threaten Parish Vitality

I am pleased to join the members of Saint Mary of the Assumption Parish Finance Council in presenting the parish's Annual Report (AR) for July 1, 2024, through June 30, 2025. The AR provides you with an overview of parish finances by presenting the Statement of Operating Activity and a review of parish life for this time and the budget for July 1, 2025, through June 30, 2026.

The many positive things in the parish's worship, faith formation (known as religious education or CCD in previous generations), service, and social life are threatened by financial insecurity. Significant projected deficits in our operating budget keep us from creating an even more robust parish life and threaten our ability to maintain current levels of ministry. When you review the financial report for last year and the budget for this year, you will notice that we continued to project a similar deficit in this year's budget. Simply put, we continue to rely on unbudgeted, unanticipated one-time gifts made to the parish to meet our operating expenses. We continue using parish savings from past generous gifts of grateful disciples to pay our bills. This is sustaining us for now, but it is not sustainable for the future. If we cannot increase income, we will need to make more cuts to expenses, primarily in staffing, that will have a direct, negative impact on the parish's ability to carry out its mission. Not addressing this now brings into question the viability of the parish and its mission.

We do not want financial insecurity to threaten the momentum of the past year, and what a year it's been! A new Deacon, Deacon Mike Judge (and his wife, Kim!) for our parish! A new Archbishop, Archbishop Richard Henning, for our Archdiocese! A new Pope, Pope Leo XIV, for our Universal Church! This year also included the start of the Jubilee Year, Pilgrims of Hope! In our parish, we implemented the next phase of family faith formation, took the next steps to move the Sacrament of Confirmation to grade 8, and initiated Jubilee Year activities.

This fall, we start the next phase of Grateful Discipleship, first introduced in January 2024, with a specific goal of increasing the parish's offertory by asking current donors to increase their offertory giving, adding new recurring donors in the parish, and promoting electronic giving, in the hopes of eliminating the gap in our financial results and allowing us to avoid significant ministry and program reductions.

Explanation of Differences Over \$10,000 to Budget

<u>Grand Annual</u>: Collections fell 22% below budget expectations. Some parishioners have increased offertory in lieu of giving to the Grand Annual accounting for some of the difference.

One-Time Gifts & Bequests and Operating Deficit: Once again, we gratefully received \$45,009 in unbudgeted one-time donations made to the parish. \$21,000 of this has been designated for roof repair from friends of the parish and from parishioners.

A MESSAGE FROM THE PARISH FINANCE COUNCIL

Fr. Scott's letter conveys the sentiments of the Finance Council and we feel its important and necessary to recap the highlights below:

Financial Overview

- ♦ **Key Concern**: Continued *chronic budget deficits* threaten the future sustainability of parish ministries.
- **♦ Current Reality:**
 - The parish is operating at a **significant deficit**, in the past 3 out of 5 years and in the projected 2025–2026 budget.
 - The parish is *relying heavily on one-time, unplanned gifts* and **drawing from savings** to meet basic operating costs.
 - This financial model is unsustainable long-term.

Implications

- ♦ **If** the financial situation doesn't improve:
 - **Staffing cuts** may occur. Other than the priests, the only full-time staff we have is the Youth Minister who is now leaving. The Collaborative Office is essentially staffed by volunteers.
 - Ministry and mission work will be impacted, reducing parish services and vitality.
 - The overall viability of the parish may be at stake.

A Year of Hope & Growth (2024–2025)

Despite financial strain, the parish has experienced **spiritual and community growth**:

- ♦ Welcomed Deacon Mike Judge and wife Kim.
- ♦ Celebrated the appointments of:
 - Archbishop Richard Henning
 - Pope Leo XIV
- ♦ Launched the Jubilee Year: Pilgrims of Hope initiative.
- ♦ Advanced family faith formation and began transitioning Confirmation to Grade 8.
- ♦ Engaged in Jubilee activities to enrich parish life.

Moving Forward: Stewardship Plan

- ♦ Fall 2025 will focus on:
 - The next phase of Grateful Discipleship.
 - Increasing offertory by:
 - Asking current donors to increase giving.
 - ♦ Recruiting new recurring donors.
 - Promoting electronic giving for consistency, stability, and planning
- Goal: Eliminate the overall deficit, stabilize finances, and avoid further cuts.

Final Thoughts

Each year, a financial budget is compiled and lays the "ground work" for what we can do to grow and enhance our Mission—not just sustain it in the coming year(s). The past year's projected deficits (and this year's projected deficit) make it difficult to meet this obligation to our parishioners.

Fr. Scott's message is a *call to action* for all parishioners to recognize that **financial participation is essential** to sustain the life of the parish.

The good news is that the parish community is thriving spiritually—but without stronger and more reliable financial support, the mission itself is at risk.

We ask that you prayerfully and gratefully participate in Grateful Discipleship 2025: Increase Offertory Project this fall.
