Notes

The parish's total budgeted revenue was \$1,176,301 while actual earned revenue totaled \$1,301,670, resulting in a favorable variance of \$125,369. Overall revenue exceeded budget expectations, driven primarily by stronger offertory collections and higher than anticipated fundraising results. Strong participation the Grand Annual Campaign led to a 29% increase over the budgeted amounts, and overall parish gifts increased by 8%. The parish also received \$12,555 of contributions and \$32,540 of Dividend income from the Inspiring Hope Capital Campaign, as well as \$52,348 of interest income from parish savings accounts. Life Teen generated \$15,500 in Mission Trip Fees and \$39,500 for Confirmation fees, and all \$44,220 in Life Teen donations were dedicated to funding mission trips. Overall revenue performance indicates steady parish support and effective fundraising execution during the fiscal year.

Parish's total budgeted operating expenses were \$1,003,225 while actual operating expenses totaled \$1,093,802, resulting in an unfavorable variance of \$90,577. Overall expenses were generally well controlled, with most categories tracking close to budget. Variances were primarily driven by staffing changes, benefit adjustments, and timing of payroll related costs. Facilities , utilities and maintenance expenses reflected normal fluctuations due to repairs and seasonal usage, while liturgical and Life Teen program expenses increased in support of parish ministries and events. Notable expenditures included \$121,880 for the Life Teen Tanzania Mission Trip and \$34,912 for ongoing Youth programs, \$16,002 in additional charitable outreach and \$7,384 for organ repair and tuning. Overall, expense management remained disciplined, with higher costs aligned to operational and ministry needs rather than structural overspending. FY24-25 Capital Improvements totaling \$144,190 included church painting, bathroom renovation, window replacement, installation of a Nativity scene, and automation of the lower church door.
