Dear Parishioners,

This year marks a significant milestone in the history of Saint Brigid Parish. Since 1875 Saint Brigid's has stood as the spiritual home for generations of Catholics living in Lexington. This 150th anniversary year provides an opportunity for us to honor our history, recognizing the steadfast faith, sacrifice, and love of the people who built this parish and who have sustained it for all these years. It is humbling to know that we are now entrusted with the mantle of carrying this legacy of faith into the future.

I am deeply grateful to you, the parishioners of Saint Brigid's, for your commitment to our parish and your continued generosity of time, talent and treasure. Over the past fiscal year, we saw a significant increase (21%) of income to the parish, particularly through regular offertory contributions and special gifts, and most importantly the return of many families to active participation in parish life. This growth is a sign of hope for our parish and demonstrates the dedication of parishioners who support our mission to share the Gospel of Jesus Christ in our community.

At the same time, as you will see in the financial statement, we continue to face a significant financial deficit. Rising costs continue to affect our operating expenses, and the ongoing needs of parish ministries and facilities maintenance are the most significant expenses that we face. While the increased revenue is encouraging, it has not yet been enough to cover our operating expenses and so we continue to draw on our reserves to cover the difference. We are committed to careful stewardship, continued transparency, and exploring creative ways to strengthen the parish's financial foundation so that our mission will remain secure for future generations to come.

Our 150th anniversary reminds us that every parish is built not only on financial resources, but above all on deep faith, prayer, and a community of believers united together as a parish family. St. Brigid's is blessed by the many parishioners who volunteer to help in numerous ways to truly make this a parish family. As we look ahead, I invite you to continue walking together in faith and hope, confident that God, who has sustained this parish for 150 years, will continue to bless and guide us for many years ahead.
