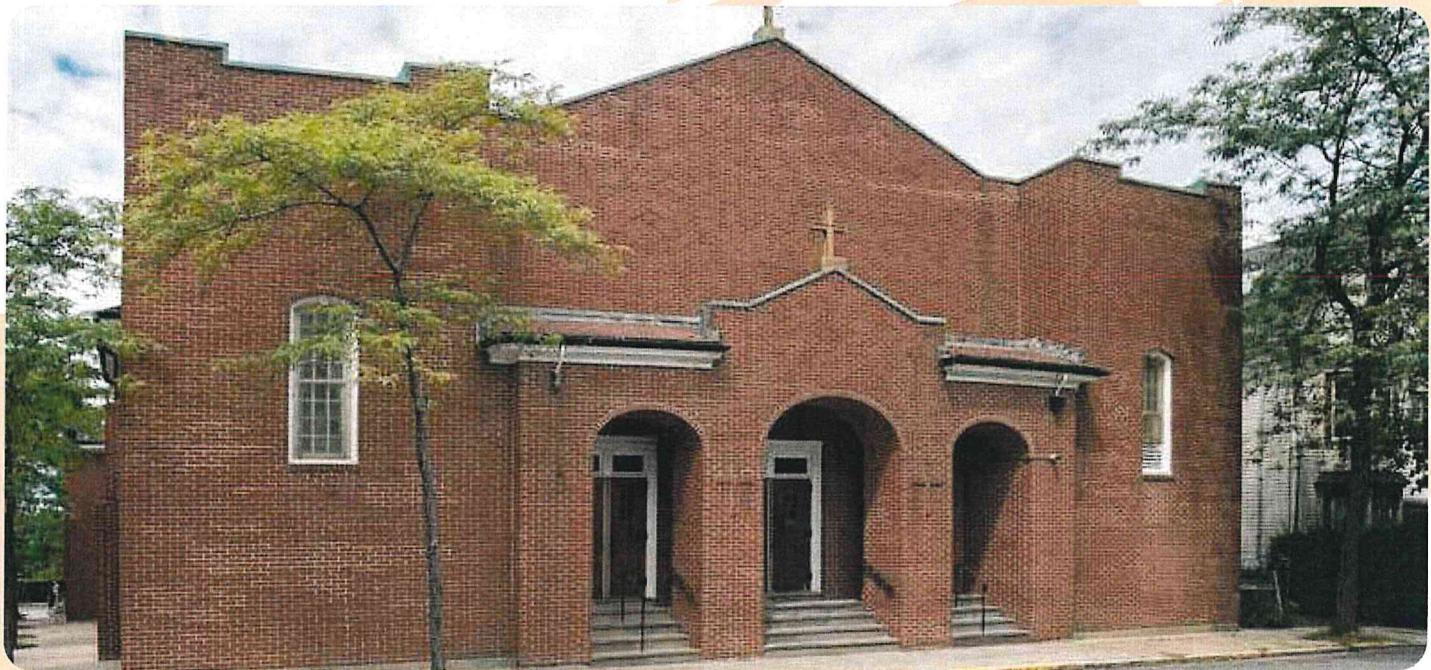

Dear Saint Benedict Parishioners,

We are pleased to present the Annual Report for the fiscal year 2025, which commenced on July 1, 2024, and concluded on June 30, 2025. The parish experienced a net gain of \$215,779 during this period. Notably, the offertory income increased compared to the previous fiscal year, reaching \$200,815, while a bequest of \$41,385 from a former parishioner contributed to the financial support. As anticipated, the lease agreement with Prospect Hill Academy Charter School continues to provide essential financial assistance to the parish in meeting its operational expenses.

The expenses incurred were less than the budgeted amount of \$63,375, primarily due to the delay in the renovations of the back stairs of the rectory and church exits. The following are the key impacts of this year's report:

Income

- Offerings exceeded projections by \$35,919, attributed to the sustained support of increasing regular offertory donations.
- Other income comprises reimbursement from Cheverus School for Rev. Alejandro's stipend and health insurance, as well as the Bequest.

Expenses

- Employee benefits expenses** exceeded the budgeted amount due to the inclusion of lay health and dental insurance for one of our priests. This is reflected in the lower expenses for Clergy Stipend, as the clergy health insurance is not used.
- Professional development expenses** are higher due to the Charismatic Renewal Retreat payments, which are offset by other income sources and travel expenses incurred by Rev. Alejandro and pastoral council members for pastoral formations.
- Capital expenditures** were reduced below the budgeted amount due to the delay in the renovations of the rear exit stairs for the rectory and church. The sole expense incurred was for the urgent repair of the rectory stairs.

For Fiscal Year 2026, we intend to allocate funds to enhance the renovation project. Specifically, we aim to address the front rectory stairs and foyer, which encompasses repairs to the roof. Additionally, the rectory windows require replacement and repair due to persistent water leaks during inclement weather.

We have established a dedicated focus on saving for this renovation and will persist in our efforts to do so. We are confident that we can attain this objective by maintaining a prudent and conservative approach to our expenditures.

In summary, the parish continues to perform well. Let us continue to collaborate effectively and be mindful of our expenses while pursuing our mission and exploring avenues for further cost savings.
