Dear Parishioners of the Light of Christ Catholic Collaborative,

It is time once again to release our collaborative's financial statement. Over the course of the last fiscal year, starting on July 1, 2024 and ending on June 30, 2025 we have seen somewhat of a drop in our offertory compared to the previous year, despite the fact that the Mass counts we have just completed throughout the month of October show that our Mass attendance has gone up slightly. I recognize that this is likely connected to the uncertainty in our economy and how tight things have gotten for many people as everything continues to get more and more expensive. For that reason, I am incredibly grateful for the generosity of the people of our parishes through the offertory and donations. Still, I have to ask every parishioner to prayerfully consider whether you are able to boost your financial support. If each of the roughly 500 people who attend one of our Sunday Masses every weekend at each church could expand their support even a little bit, it would quickly stabilize our financial situation over the 50 parish weekend collections each year. Your financial support is essential for our ability to keep advancing our mission of making Christ present in the towns of Abington and Whitman. I also want to thank you all for continuing to support through generously sharing your time and talents which are also essential for our being able to flourish. I cannot express how much I appreciate all that you do to allow our parishes to continue to provide the Sacraments, religious instruction, and opportunities for prayer and reflection.

This was financed partly through a generous grant from the McNiece Foundation Fund which is helping us to strengthen the school in a number of ways. I know that the school's strength comes from the dedication of our whole community; teachers, staff, students and families. I am honored to be a part of this community and very glad to see all that is happening there to make the school continue to grow as an institution of learning, virtue and mutual support.

I would like to thank Dennis Leonard, our Finance and Operations Manager, and the Finance Council for all their work, including the preparation of this report, as part of their review of the statements and budgets for the parishes, school and cemeteries of the collaborative. Their expertise and willingness to share their time and talent are a huge help and I can't imagine trying to understand and manage the collaborative without their assistance.

Once again, please look over the financial report and prayerfully consider whether you are able to help us bring our offertory back up to the budgeted amounts. Whether you are able to or not, I want to thank you for your generosity and prayerful support. I know that God has amazing things planned for us and I am looking forward to seeing what the next year will bring.
