PAYMENT PLANS

FACTS Payment Plans: All families <u>must</u> have a FACTS Payment Plan setup (1, 2, or 10 installments) which will include recurring automatic withdrawal through checking, savings, or credit card accounts. All fees are non-refundable.

Parents who enroll their child(ren) agree to the following:

The Pastor, Principal and Finance Board have set the tuition and contracted with the staff based on your child being here. Once the Tuition Contract is signed and the registration fee paid, the contract is a binding obligation by the parties signing the contract. If you withdraw your child from Saint Bridget School after the Tuition Contract has been signed, you must submit a written request to the Principal. Please refer to our Tuition Refund Policy for further details.

TUITION REFUND POLICY

Students who withdraw prior to the end of the school year are financially responsible for all tuition. Notification is required and must be submitted to the Principal. Tuition must be current and up-to-date before the withdrawal process can begin. If your account is not in good standing, school records will not be sent to the new school and your past-due balance will be sent to collections. Enrollment/re-enrollment fees are not considered tuition payments and will not be refunded in the event of a withdrawal. There is no tuition refund for students expelled for disciplinary reasons.

Because expenses are incurred from the moment that students are enrolled, families must be responsible for all or a portion of tuition upon withdrawal. The following schedule outlines the amount of tuition due based on the timing of withdrawal:

- Withdrawal prior to July 1st no tuition is due.
- Withdrawal from July 1st to the first day of school 25% of tuition is due.
- Withdrawal between the first day of school and November 1st 50% of tuition is due.
- Withdrawal between November 1st to February break 75% of tuition is due.
- Withdrawal from the return of February break through the end of the school year 100% of tuition is due.
