LOA - seasonal worker	summer hire, cemetery worker; usually NBE	also change to NBE if not already
LOA - occasional worker	musician, sub teacher, after-school aide, etc.	also change to NBE if not already
LOA - school employee - summer	teacher aide, not paid over summer; often BE	keep BE status as is
LOA - medical	employee on unpaid sick leave (not work-related)	keep BE status as is (for 6 months)
LOA - workers compensation	work-related injury	keep BE status as is (for 6 months)
LOA - personal	leave to help family business	contact Benefits Department
LOA - military	service in armed forces	contact Benefits Department
LOA - temporary layoff	lack of work, subject to recall	contact Benefits Department

C3	Calendar Year - The sick balance is to be manually populated by the Business Manager, Fin Ops, Payroll Admin etc... as of January 1st each year
F1	Fiscal Year- 40 Hours of Sick Time are auto populated July 1st of each year.
F2	Fiscal Year - The system will calculate and accrue 1 hour of sick time for every 30 hours an employee works. The accrual will cap at 40 hours and carryover into the next fiscal year.
F3	Fiscal Year - The sick balance is to be manually populated by the Business Manager, Fin Ops, Payroll Admin etc... as of July 1st each year.
A1	Academic Year - 40 Hours of Sick Time are auto populated September 1st of each year.
A2	Academic Year - The system will calculate and accrue 1 hour of sick time for every 30 hours an employee works. The accrual will cap at 40 hours and carryover into the next academic year.
A3	Academic Year - The sick balance is to be manually populated by the Business Manager, Fin Ops, Payroll Admin etc... as of September 1st each year.
