## **Pilgrimage: Wednesday, September 17, 2025**

All are invited to join our Pilgrimage departing from **St. Albert the Great** parking lot to the **National Shrine of Our Lady of Champion** on **Wednesday, September 17, 2025**. The cost is **\$65 per person** and covers transportation, lunch, and gratuities. Cost is non-refundable (unless a substitute person can fill your spot). Water and treats will be available on the bus.



We will be visiting the National Shrine of our Lady of Champion, Champion WI. We will celebrate Mass at the Shrine. You'll have time to tour the Shrine, and experience multiple devotional areas on the Shrine's grounds. *Please note walking is required.*

We will board the bus at 7:00am at the upper parking lot of St. Albert the Great church. The bus will leave at 7:15am. We will depart Champion at 3:00pm with arrival back at church at approximately 5:30pm.

As part of our pilgrimage, a rosary will be prayed going to Champion and the Divine Mercy Chaplet will be prayed on the return trip. This event is sponsored by St. Anne's CCW.
