# **Registration Procedures**

The acceptance of your student's registration requires:

- St. Regis FACTS tuition agreement created (new families) or updated (returning families).
- Signed and submitted Enrollment Contract and Packet (includes required school forms).
- Family tuition deposit paid in full.
- Health Appraisal form with immunization information submitted for students entering Developmental Kindergarten, Kindergarten, 7<sup>th</sup> grade, and all new students. The Health Appraisal must be signed by a physician and provide up-to-date immunization status or a valid medical or non-medical waiver from the local county Health Department.

# Non-Refundable Deposit/Fees (included in totals on previous page) Per Family

#### • Family Tuition Deposit:

\$500.00

The family tuition deposit will be credited towards the tuition of the oldest (or only) child. The tuition deposit is non-refundable if the family withdraws from St. Regis.

#### • Family Fundraising Raffle Fee:

\$200.00

All families are required to participate in the Fundraising Raffle and will receive \$200 worth of raffle tickets. There is the option to sell the raffle tickets. Tickets must be paid for with the July tuition installment in FACTS for the raffle drawing. Drawing dates and ticket distribution dates to be announced.

#### 8<sup>th</sup> Grade Graduation Fee (not included in totals on previous page)

• 8th Grade Graduation Fee:

\$100.00

This fee is charged for 8<sup>th</sup> grade students. Its covers: Rose & Candle ceremony, graduation ceremony, cap, and gown.

# **Tuition with Parish Discount Eligibility**

The parish discount tuition status will ordinarily be granted after one year, if the following criteria are met:

- At least one parent/legal guardian is Catholic and registered at St. Regis Parish.
- Child(ren) are baptized and all sacramental information is on file at St. Regis Parish.
- Regular participation in Sunday worship at St. Regis.
- Consistent involvement in one or more St. Regis Parish ministries (Christian Service, Liturgical ministries, CYO coaching, etc.)
- Consistent contributions to the St. Regis Parish offertory and annual Catholic Services Appeal (CSA). We encourage families to donate as generously as they can, given their financial circumstances.

All parish registrations completed after December 31, 2024 will be without the parish discount for the 2025/26 school year, unless there is an indication of prior involvement in another Catholic parish from outside the metro Detroit area. Accounts that receive the active parishioner tuition discount are reviewed annually and approved by the Pastor.



# **Tuition Payment Options**

To assist our families, St. Regis Catholic School offers 5 tuition payment plan options ALL of which are administered through FACTS Tuition Management (one enrollment per family):

- 1. Single Installment A single payment due no later than July 15th
- 2. 8 Installments 8 equal payments: July February (Choice of 1<sup>st</sup> or 15<sup>th</sup> Due Date)
- 3. 9 Installments 9 equal payments: June February (Choice of 1<sup>st</sup> or 15<sup>th</sup> Due Date)
- 4. 10 Installments 10 equal payments: May –February (Choice of 1<sup>st</sup> or 15<sup>th</sup> Due Date)
- 5. 11 Installments 11 equal payments: April February (Choice of 1<sup>st</sup> or 15<sup>th</sup> Due Date)

All families are required to set up a FACTS Tuition Management account which is good for their entire tenure at St. Regis Catholic School. Each year, families need to update their accounts during the registration process to ensure their information remains current and the payment information and options are correct. Failure to enroll in FACTS will result in the loss of the student's registration status and the student will lose their place in the program along with the family tuition deposit.

#### **Tuition Assistance**

Assistance is available for families in need through two programs: The Archdiocese of Detroit Tuition Assistance Program and St. Regis Tuition Angels Financial Aid fund. To be considered for assistance from one or both programs, parents must submit the FACTS Student Grant & Aid application found on the FACTS Tuition System. The application can only be completed online. The Archdiocese offers assistance for students in Kindergarten through 8<sup>th</sup> grade. #### **Notes:**

- Parents/guardians unable to make tuition payments on schedule are REQUIRED to contact the Parish Business Office at businessoffice@stregis.org immediately.
- A student's financial obligation must be current to begin school in the Fall, at each semester quarter start, and to begin the second semester. Any student with a delinquent balance may be subject to exclusion from school activities.
- Payments received after the specified due date will result in the charge of a \$35 Late Fee.
- Payments that are returned for insufficient funds will be assessed a \$30
   Nosufficient Funds Fee.

## **Tuition Refund Policy**

A student is considered enrolled once their registration is complete and the tuition year has begun (July 1). The semester tuition is due prior to the start of a semester. Should a student withdraw or be asked to leave St. Regis Catholic School, they forfeit the family tuition deposit. The net semester tuition will be reimbursed, if applicable, as follows:

Withdraw during week 1 & 2	100 % of net semester tuition (less \$500.00 tuition deposit)
Withdraw during week 3 & 4	75 % of net semester tuition (less \$500.00 tuition deposit)
Withdraw during week 5 & 6	50 % of net semester tuition (less \$500.00 tuition deposit)
Withdraw during week 7 & 8	25 % of net semester tuition (less \$500.00 tuition deposit)
Withdraw week 9 and after	0 % NO tuition refund

The Parish Business Office will calculate and process the refund. The family will receive information with the calculations along with the refund check. Please allow two weeks for processing.
