## **FINANCE REPORT**

• Treasurer Bonnie Beardsworth gave a well rounded summary of the FY 26 budget.

#### **OLD BUSINESS**

- Financial Feasibility Vetted Companies
  - Angela reported that the Regina Board had granted permission in June to seek diocesan approval to begin a financial feasibility study. Bishop Walsh approved the request on July 1.
     Angela vetted and interviewed three companies: the Institute for School and Parish Development (ISPD), Partners in Mission, and the Steier Group. Processes are similar, costs vary. The Board determined they would like the Steier group to come and present at the November board meeting to help finalize which company will be used.
    - Steier Group (worked with Regina and Diocese of Davenport)
    - Partners in Mission (highly recommended)
    - Institute for School and Parish Development (highly recommended)

## **Baseball and Softball Completion**

The baseball project is complete, with final irrigation work finished in September. Donors
covered all project costs, including overages from scope changes and communication
challenges. Angela gave an overview of the project pros and cons. The softball project will
be funded through the school budget to ensure Title IX compliance and will include only
backstop netting and padding.

## **NEW BUSINESS DISCUSSION**

- By-Laws Financial Approval
  - The Regina Board is awaiting clarification from the Diocese on this.
- Board Meeting Frequency
  - The Regina Board discussed how often they should convene during the year to ensure effective oversight and timely decision-making.

- A calendar was presented for consideration outlining organizational events and reporting deadlines. The calendar is intended to help align board actions and decisions throughout the year.
- The decision was made to have a monthly meeting at 5:30pm on every fourth Tuesday of the month except the month of December.
- Affiliate Organization Proposed Projects Angela provided updates on the fundraising priorities of the affiliate organization:
  - Home and School will be asking to fundraise for a red playground update planned for summer of 2027, in addition to current activities. The project will require Board approval to move forward. No action is needed at this time, but it is noted within ongoing projects.
  - The Booster Club is requesting to fundraise for stadium light upgrades. Quotes are being obtained and they are asking to launch a fundraiser for football lights using the Foundation's alumni database. Key considerations include Regina's identified facilities needs, softball, the upcoming feasibility study, and the Foundation Excellence Fund campaign. The project will require Board and Bishop approval to proceed. The Foundation expressed caution and requested to join the next meeting. Jeff Harney and Sarah Tierney from the School Board will also plan to attend.
