## INFORMATION REGARDING THE MARRIAGE TO BE DISSOLVED

*By requesting a dissolution of the bond in favor of the faith, you are asking the Roman Pontiff to dissolve your non-sacramental marriage in order that you may enter a second marriage. The faithful in the Church have no right to obtain a dissolution of the bond; rather, the exercise of this power by the Pope is a favor which can only be granted in some circumstances. For example, Catholics who have already been in a valid non-sacramental union can only be granted a dissolution if the intended marriage will be with another baptized person. Consequently, a request for a dissolution of the bond in favor of the faith must include some basic facts about the marriage to be dissolved. **If your petition is accepted by this Tribunal, we will be sending you a set of questions about the marriage being dissolved. They will cover the following areas of interest:***

- I. Basic details about the premarital relationship between you and your former spouse.
- II. Basic details about the practice of faith during the marriage.
- III. Basic details about why the marriage failed, especially regarding who caused the breakdown of the marriage.
- IV. Basic details about your current/intended spouse.

**Fees for the Process:**

While our Tribunal does incur expenses for this process, we subsidize our costs by means of the Diocesan Services Fund (DSF) so that this service might be offered to you as a ministry. As a result, we do not charge a fee for our Tribunal services; however, any fees required by the Dicastery for the Doctrine of the Faith (DDF) in Rome must be borne by the Petitioner. Currently, the DDF charges \$530. **So, we ask that you please send with this petition a check for \$530 payable to the Metropolitan Tribunal of the Archdiocese of Galveston-Houston. In the event that your petition is not accepted or is otherwise ended or abandoned before it is sent to the DDF in Rome, your check will be voided and returned to you.** If you cannot afford this fee, you can request financial assistance from the Judicial Vicar.

**Please sign and date the statement below:**

I understand that a dissolution of the bond in favor of the faith is a favor granted by the Holy Father and is in no way a right which is owed to me or to anyone else. As such, I request that the Archbishop of the Archdiocese of Galveston-Houston and his delegate(s) assist in the instruction of the cause in order to prepare the request to be sent to the Holy Father for his consideration.

I attest that there is no possibility of restoring the partnership of the conjugal life of the marriage which I am requesting to be dissolved. Furthermore, I attest that I was not the exclusive or prevailing culpable cause of the breakup of the conjugal common life, nor did my intended spouse by his/her own fault provoke the separation of spouses.

I hereby release any and all materials gathered for the instruction of this process to the Metropolitan Tribunal of the Archdiocese of Galveston-Houston, to other experts if necessary, to the Dicastery for the Doctrine of the Faith, and to the Roman Pontiff.

I understand that no guarantee can be made as to the outcome of the request, that no definite time frame for a completion date can be established, and that **no date for a new marriage can be set by a parish priest or deacon unless the favor is granted.**

I understand that it is my responsibility to make payment for any fees charged by the Dicastery for the Doctrine of the Faith when so notified by the Metropolitan Tribunal of Galveston-Houston.
