Mass for the Holy Year of Jubilee 2025

The Church celebrates the "year of favor from the Lord" Introduction

The theme of the Jubilee Year 2025, "Pilgrims of Hope," is uniquely captured in the prayers, readings, and options of the Mass for the Holy Year. They stress the themes of pilgrimage and hope. Incorporated into Christ, the faithful are a Body of believers, filled with hope. They look forward to the Lord's coming in the present and at the end of the ages, an expectation which gives them an eternal vision and moves them to make pilgrimage to God and neighbor.

Approved by the Holy See on May 13, 2024 in eight languages, the Mass for the Holy Year may be used in the liturgy for the duration of the Jubilee, celebrated in the dioceses of the United States from

December 29, 2024 to December 28, 2025. It contains three formularies, a set of Lectionary readings, five sets of tropes for the Penitential Act, and four sets of introductions, responses, and conclusions for the Universal Prayer (Prayer of the Faithful).

A RECENT VATICAN RULING ON THE OBLIGATION TO ATTEND MASS WHEN A HOLY DAY IS TRANSFERRED

Dear Colleagues,

This comes to provide an update on the issue of the obligation to attend Mass when the DATE of a holyday has been transferred. You may recall that the issue arose in 2024 when the Solemnity of the Immaculate Conception was transferred to Monday, December 9 because the Second Sunday of Advent (a day of higher rank) fell on December 8.

Following the ruling last fall by the Dicastery for Legislative Texts, several requests for clarification were sent to the Dicastery for Divine Worship and Discipline of the Sacraments. Last week, Cardinal Arthur Roche, Prefect of the DDWDS issued a response (Prot.51/25). The full text of that response is attached in English and Spanish.

KEY POINTS:

- The Dicastery responded to a specific question "[I]n the case of the transfer of a holyday of obligation, is one bound on the day *ad quem* to observe the obligation to attend Mass?"
- The response references the Universal Norms for the Liturgical Year and the Calendar and its Table of Liturgical Days According to Their Order of Precedence (cf. nos. 59-60).
- Recognizing that this was a liturgical matter not expressly regulated by the Code of Canon Law (CIC), the Note acknowledges a "well-established practice" that the Dicastery had followed.
- The note concludes "Since this practice is not contrary to the canons of the CIC, it is to be considered liturgical law (cf. Canon 2) that in the event of the occasional transfer of a holyday of obligation, the obligation to attend Mass is not transferred to the day *ad quem*."
