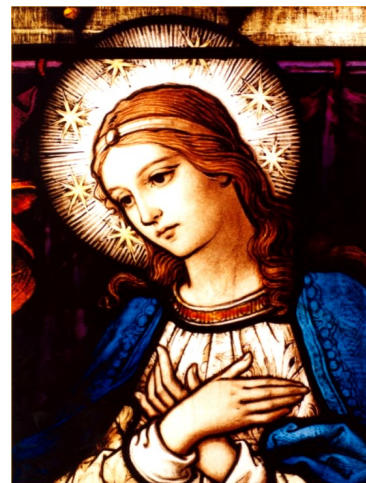

The Following Announcement Is From Father Tom Metzger,

Parishioners of the three parishes in the Anderson-Alexandria Pastorate, at St. Ambrose and St. Mary's in Anderson, and St. Mary's Alexandria, have been asking about how the new clergy assignments will affect each of their parishes, specifically the Confession and Mass schedules.

The weekend Confession and Mass schedules will remain the same until further notice. While changes may be needed and helpful suggestions are already being made, the priests who are coming to our parishes do not intend to make any changes that might turn out to be hasty and disruptive. More consultation will be needed before any changes are made, and if there are any changes, they will be communicated well in advance. For now, the Confession and Mass schedules will continue as they are.

The three parishes of the Pastorate will be served by four clergy: Father Tom Metzger, Pastor, Associate Pastors Father Dave Hellman and Marty Sandhage*, and Deacon Michael Burns.

Fr. Hellmann will live at the rectory in Alexandria. Fr. Metzger and Fr. Sandhage will live in the rectory at St. Mary's in Anderson. Primary office space for all three priests will be at St. Ambrose, and they will also use office space at St. Mary's in Alexandria. Deacon Burns, who lives in Henry County, will minister at all three parishes and will also use work space as needed at St. Ambrose and Alexandria.

The effective date for the new assignments is Wednesday, August 19, so the incoming priests will first celebrate Mass in our parishes the weekend of August 22nd and 23rd.

Your patience is appreciated as these transitions take place. Our incoming clergy are looking forward to settling in and getting started with their ministry in the parishes of our Pastorate.

El siguiente anuncio es del padre Tom Metzger,

Los feligreses de las tres parroquias en el Pastorado Anderson-Alexandria, en St. Ambrose y St. Mary's en Anderson, y St. Mary's Alexandria, han estado preguntando cómo las nuevas asignaciones del clero afectarán a cada una de sus parroquias, específicamente la Confesión y la Misa. horarios.

Los horarios de confesión y misa del fin de semana serán los mismos hasta nuevo aviso. Si bien pueden ser necesarios cambios y ya se están haciendo sugerencias útiles, los sacerdotes que vienen a nuestras parroquias no tienen la intención de hacer ningún cambio que pueda resultar apresurado y perjudicial. Se necesitarán más consultas antes de realizar cualquier cambio, y si hay algún cambio, se comunicarán con suficiente antelación. Por ahora, los horarios de Confesión y Misa continuarán como están.

Las tres parroquias de la Pastoral serán atendidas por cuatro clérigos: el padre Tom Metzger, el pastor, los pastores asociados, el padre Dave Hellman y padre Marty Sandhage *, y el diácono Michael Burns.

El padre Hellmann vivirá en la rectoría de Alejandría. El padre Metzger y el padre Sandhage vivirá en la rectoría de St. Mary's en Anderson. El espacio de oficina principal para los tres sacerdotes estará en St. Ambrose, y también usarán el espacio de oficina en St. Mary's en Alejandría. Deacon Burns, que vive en el condado de Henry, ministrará en las tres parroquias y también usará el espacio de trabajo según sea necesario en St. Ambrose y Alexandria.

La fecha efectiva para las nuevas asignaciones es el miércoles 19 de agosto, por lo que los sacerdotes entrantes primero Celebremos la misa en nuestras parroquias el fin de semana del 22 y 23.

Su paciencia es apreciada a medida que ocurren estas transiciones. Nuestro clero entrante está ansioso por establecerse y comenzar su ministerio en las parroquias de nuestra Pastoral.
