PROCEDURE FOR LACK OF FORM CASE

To be submitted:

- 1. Petition form for <u>EACH</u> marriage in question.
- 2. Recent copy of BAPTISMAL Certificate of Catholic party bound to Canonical Form of marriage. (NOTE: Baptismal Certificate MUST have annotation that there are no marriages recorded for Catholic party. If both parties are baptized Catholic, copies of both baptism certificates should be submitted with the application).
- 3. Copy of MARRIAGE CERTIFICATE.
- 4. CERTIFIED copy of <u>FINAL</u> DIVORCE DECREE OR ANNULMENT (certified copy, not lawyer's copy.)
- 5. All questions must be answered. If the Catholic party ever left the Catholic Church or at anytime no longer considered himself/herself a Catholic, it must be determined if such action constituted a "formal act". Consult the Tribunal in such cases.
- 6. Complete address of the respondent <u>MUST</u> be given. Respondent must be notified.
- 7. Information must be given regarding the fulfillment of the obligations toward respondent and/or the children arising from this marriage. Cf. Question #6.
