

MESSAGE FROM OUR STATE ATTORNEY

Happy holidays everyone! It's hard to believe the end of 2017 is upon us. I wish you and your families a Merry Christmas season filled with time to relax and spend time with your loved ones.

Question: What is the law regarding texting while driving?

The Texas legislature recently enacted a law which prohibits reading, writing or sending electronic messages via a wireless

it can wait

communication device. This law, which became effective on September 1, 2017, will ban texting or engaging in any kind of written communication while driving across the state of Texas.

However, drivers may still use their phones for talking as well as certain other functions, such as GPS navigation and music. Motorists may also use their phones to report a crime and seek emergency assistance. In addition, hands-free technology,

such as Bluetooth headsets or dictation functions, is also permitted.

In addition to the state-wide

ban, certain cities throughout Texas have passed ordinances providing for stricter cell phone bans. There are also state laws in

> place to prevent drivers from texting in school zones.

A texting while driving offense is punishable by a fine of \$25-99 for first time offenders, and \$100-200 for repeat offenders. If an accident


caused by texting and driving results in death or serious bodily injury of another person, the offender can be charged with a Class A misdemeanor punishable by a fine not to exceed \$4,000 and confinement in jail for a term not to exceed one year (in addition to any other charges/punishments).







Prayers are contagious. Start a prayer chain and see for yourself just how far one prayer can travel.

The power of prayer is unspeakable. It's unexplainable. It's simply amazing.

Luke's story is just that. It's about how one family stands next to their one-year son who has fought cancer now most of his life, and how the power of prayer can lift a family's spirits and help them find the strength they needed to help their little boy fight for his life.


Luke was a relatively healthy baby, and all was great at his one-year check-up. Not three weeks later, his father and mother, Lucas and Mindy, noticed bruising and tiny red dots (petechiae) all over his body and Luke was just not his normal happy self. After a short visit to Luke's pediatrician, Fort Worth. Within a couple of hours, they were introduced to an oncologist who delivered those words that any parent never wants to hear, "Your son has leukemia."

It was at that moment on July

Luke was diagnosed

with Acute Myeloid

Leukemia (AML) M7,



Luke's treatment plan consisted of three rounds of extremely strong chemotherapy, with three different chemotherapy drugs administered each round for multiple days, as well as a bone marrow transplant.

Before Lucas and Mindy could even wrap their heads around all that was happening, Luke underwent surgery for placement of his central line, and the first round of chemotherapy was underway immediately.

Thoughts of "why Luke" or "what did we do wrong" began to fill their minds as they watched their baby boy endure more pain, pokes and prods than any child should ever have to. The fear treatment, how the family would make it financially and

how Luke's two older sisters would do with both parents living at the hospital haunted Lucas and Mindy.

Cook Children's Medical Center in Fort Worth became Luke's new home as he quickly learned where the playroom was on the oncology floor, what days the Art Therapist and Music Therapist would come to play, and how to become the nurses' favorite. Luke's first hospital stay lasted 73 days which was filled with two rounds of chemotherapy (both lasting several days), numerous visits from family and friends, numerous tests and scans to ensure all his organs were functioning properly, and Luke's favorite time of all....Popsicle Hour every day at 4 pm. Luke had good days,

and bad days during this first hospital stay as every day there was a new hurdle to climb. There were days where Luke was in too much pain to walk, days when he didn't have much of an appetite or even days where he was isolated to his hospital room due to fever. Fortunately for Luke, the good days outnumbered the bad, and he enjoyed walking the halls with Mindy, riding in his car around the oncology floor and playing in the oncology floor playroom....all while being connected to an IV pole with fluids, medications and/ or chemotherapy running. Luke looked forward to the afternoons when his sisters, Molly and Maggie, would get to visit and play and when Daddy would get back from work. This was the Friedel Family's new

social isolation. Any illness or fever would send him immediately back to Cook Children's Medical Center for a hospital stay until his bone marrow transplant at the end of October.

On October 19th, 2016, Luke underwent surgery for placement of his mediport. While he still had his central

life. Mindy instantly becoming a stay-at-home mom, Mindy's mom moving in to help care for the girls, and having playtime and dinnertime at a hospital. While it was a difficult 73 days, Lucas and Mindy knew there was nothing else they would do except fight right alongside their precious baby boy.

After just one round of chemotherapy, Luke was in remission! The second round of chemo was administered as "maintenance" to ensure the leukemia did not return before Luke would have his bone marrow transplant. Luke was able to enjoy time at home for three weeks at the end of September and beginning of October; however, home is the only place he was allowed to be. During this time, no visitors were allowed, and the Friedel Family was not able to go places altogether as Luke was in strict

line, the oncologist felt it was necessary to place a mediport as well to ensure several means of getting him medication if need be. This was also the day that Luke was admitted to the bone marrow transplant unit at Cook Children's Medical Center. Luke was administered the most intense round of chemotherapy drugs for the next several days in preparation for his bone marrow transplant.

On October 26th, 2016, Luke

with leukemia. Luke developed mouth sores from the intense chemo, not only in his mouth but all the way down his gastrointestinal tract, which were very painful. He was unable to talk, swallow or eat and Lucas and Mindy found themselves having to suction his mouth to prevent him from gagging. In order to keep up his nutrition, a feeding tube was placed down his nose which was not something Luke enjoyed. It was a daily struggle to get Luke to eat or drink anything! One of the hardest things during this hospital stay was that Luke was only allowed to see his sisters through a glass window. He wasn't able to play with them in the transplant unit playroom. He missed out on trick-or-treating with them, and Luke and his parents spent Thanksgiving at Cook Children's, away from his sisters and grandparents. Lucas and Mindy longed for the day that all 3 of their children could hug again.

December 1st, 2016, Luke "broke out" of the bone marrow transplant unit and was able to go home finally! While this was a joyous occasion, Luke still had several restrictions once outside of the hospital. He was not allowed to go anywhere. When he was outside his home for clinic visits he had to wear a mask, he couldn't play on any public playgrounds, or outside in the dirt. He had a strict food guideline, and the amount of medication that Luke had to take daily was unbelievable.

Once discharged from the hospital, Luke had clinic visits three times a week for the first several weeks until eventually, it changed to every two weeks and then to once a month. Each clinic visit Luke continued to amaze his oncologist by how well he was responding to the bone marrow transplant. At day 100 post-transplant, which was in February 2017, several restrictions could gradually be lifted, and Luke was able to make his first trip, since diagnosis, to Fayette County in March.

Over the next several months, Luke continued to do well, he enjoyed being at home, and he was acting like a typical toddler boy climbing on top of everything! Luke broke his collar bone in April 2017, but after all that he had already been through, having his arm in a sling for six weeks didn't slow him down at all!

On October 26th, 2017, Luke celebrated his one-year bone marrow transplant "birthday." This was a huge milestone in Luke's battle against leukemia. Luke is no longer on any of the medications that he was taking on a daily basis, the Friedel Family can go places together as a family of 5, and Luke can be a kid again! Luke's oncologist had one goal in mind since diagnosis, and that was to give Luke "new" life through a donor bone marrow transplant.

At one-year post-transplant, blood tests performed by his oncologist showed Luke's

bone marrow to be 99.9% the donor's. Success is the word the Friedel Family heard from Luke's oncologist.

At just 13 months old, Luke started the biggest battle of his life, and now at 2 ½ years old, he is a bone marrow transplant survivor and cancer free!

As the past year and a half have been an emotional roller coaster for the Friedel Family, they never lost hope and always turned to

prayer to get them through each day. They believed from the start that God was in control of what was to happen to Luke and believed that God would one day heal their baby boy. Luke is

a hero, a fighter, and a true miracle

and Lucas and Mindy believe that God has big plans for Luke's future. While Luke's battle against leukemia will last a lifetime, the Friedel Family takes one day at a time, enjoys every moment as a family of 5, and trusts that God will forever heal their baby boy.

The amount of the support, thoughts, prayers, and donations that the Friedel Family received during this difficult time was unbelievable. All of Fayette County came together as one to support Luke's battle against leukemia. The Schulenburg High School Class of 2004 held several bake sales and a drive-thru dinner in honor of Luke, as did the LaGrange High School Class of 2001. St. Mark's Medical Center in LaGrange adopted the Friedel Family last Christmas and provided gifts for the entire family, and the KJT of Schulenburg held a Turkey Shoot in honor of Luke. Numerous other organizations in Fayette County also provided donations to the Friedel Family for which they are forever grateful. Lucas and Mindy know and have seen that their son is a fighter, but it is always comforting to know that they



are not in this battle alone. They believe that the best gift that anybody could ever give is prayer. Prayer that Luke continues to be cancer free and that he continues to have minimal side effects from the chemotherapy.

Luke has accomplished so many milestones thus far, and the Friedel Family has learned to just take one at a time, celebrating all of them. Luke's next big milestone will be his port removal which is scheduled for December 6th, 2017. Luke and his family also look forward to the day, sometime soon, that they get to meet the young man who gave Luke a "new" life!

In new business, a member social and meal were set for


Sunday, December 18th in conjunction with the final meeting of the year.

awrence Vrazel Jr., 87, of Yarrellton, died Saturday November 11, 2017, in a Temple hospital.




