MESSAGE FROM OUR PRESIDENT

Happy New Year!

Happy New Year and well wishes for a very successful year! I would like to thank all KJT members, society and district officers, insurance representatives, home office staff, and state directors and officers for all that you do! In 2021, KJT once again showed positive results financially, but membership numbers continue to be a concern. Hopefully, with all of us working together, we can make 2022 a successful year both financially and membership wise.

43rd General Convention – July 2022

The 43rd General Convention will be held on July 15-17 at the Hilton College Station and Conference Center! All societies were mailed credential packets at the end of 2021 and are due back to the Home Office by March 31, 2022. Additionally, resolutions for changes to the Constitution or By-Laws are due to the home office no later than February 21, 2022. Resolutions received prior to the February 21 deadline will be distributed

to all societies prior to the convention for deliberation. Resolutions received after this date will be presented at the convention; however, societies may not have previous knowledge of these resolutions to consider prior to the convention.

Director Elections at the Convention

While I have been informed by all incumbent state directors that they are once again running for their positions, members may run for one of the positions. In order to qualify to seek the position of state director, one must be eligible to serve as a delegate to the convention. Candidates must submit an application of candidacy stating which position they are seeking and consent to a background check. Candidates can request this form from the Home Office and the form must be filed with the KJT State Secretary between February 1 and April 1 of this year. Candidate applications will be reviewed by a qualifications committee and the candidate will be

notified if the application is approved or disapproved.

Financials

I am happy to report that KJT's financials continue to look good even in this extended low interest rate environment. Through Q3 of 2021, KJT's surplus is up more than 12% compared to Q3 of 2020 and now sits at \$7.002 million. As reported earlier in the year, KJT has surpassed the \$100 million mark in assets and at the end of Q3 2021, assets sit at \$103.647 million. Additionally, KJT's assets to liabilities ratio is now 107.25% which indicates that KJT has \$107.25 in assets for every \$100 of liabilities and is in solid financial condition and able to meet its obligations as they come due. The financials for Q3 2021 can be found on page 8 of this issue for your review.

Membership

Membership numbers continue to be a concern as KJT's total membership



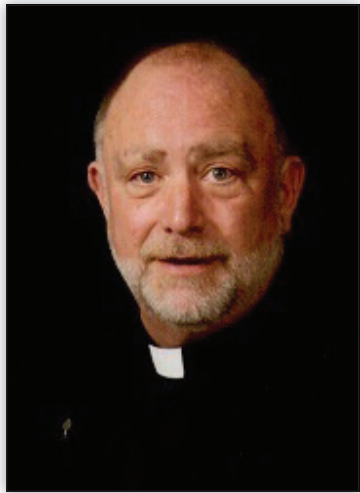

St. Angela Merici's feast day is January 27. St. Angela founded the Ursuline Sisters in the early 16th century primarily for the education of

young women. She was also often known to say, "Disorder in society is the result of disorder in the family."

In 1968, Pope St. Paul VI wrote an encyclical letter to the Church entitled "On the Regulation of Birth" (*Humanae Vitae*) in which he predicted:

Responsible men can become more deeply convinced of the truth of the doctrine laid down by the Church on this issue if they reflect on the consequences of methods and plans for artificial birth control. Let them first consider how easily this course of action could open wide the way for marital infidelity and

a general lowering of moral standards. Not much experience is needed to be fully aware of human weakness and to understand that human beings—and especially the young, who are so exposed to temptation—need incentives to keep the moral law, and it is an evil thing to make it easy for them to break that law. Another effect that gives cause for alarm is that a man who grows accustomed to the use of contraceptive methods may forget the reverence due to a woman, and, disregarding her physical and emotional equilibrium, reduce her to being a mere instrument for the satisfaction of his own desires, no longer considering her as his partner whom

he should surround with care and affection. (n. 17)

Can there be any doubt, with what we have experienced in our society in the past 54 years, that St. Angela Merici (and Pope St. Paul VI!) knew exactly what she was talking about? Indeed, "Disorder in society is the result of disorder in the family."

As we begin another New Year, let us resolve to heed Pope St. Paul VI's exhortation to us all but especially to Christian married couples:

...let Christian husbands and wives be mindful of their vocation to the Christian life, a vocation which, deriving

from their Baptism, has been confirmed anew and made more explicit by the Sacrament of Matrimony. For by this sacrament they are strengthened and, one might almost say, consecrated to the faithful fulfillment of their duties. Thus will they realize to the full their calling and bear witness as becomes them, to Christ before the world. For the Lord has entrusted to them the task of making visible to men and women the holiness and joy of the law which united inseparably their love for one another and the cooperation they give to God's love, God who is the Author of human life. I realize activity has been down in 2021 due to the pandemic, however, over \$23,000 was still raised for these worthy charities.

KJT Scholarships

Over the last four years, the board has doubled the amount that will be awarded in college scholarships to graduating high school seniors who have been members for at least one year as of March 1, 2022. \$30,000 is now allocated toward the scholarship program. We have seen the number of scholarship applications dwindle in the last few years, so I highly encourage your high school graduate to apply for these scholarships. The deadline to submit an application for the state scholarships is March 1, 2022.

Additional scholarships (the number to be deter-

mined at the annual meeting in March) will be available through the KJT Memorial Foundation for students who will continue their education at a vocational or technical college. The deadline for scholarship applications is March 1, 2022.

I would once again like to wish you a Happy and Healthy New Year. With God’s blessings, hopefully we can get past this pandemic and get back to some sense of normalcy. 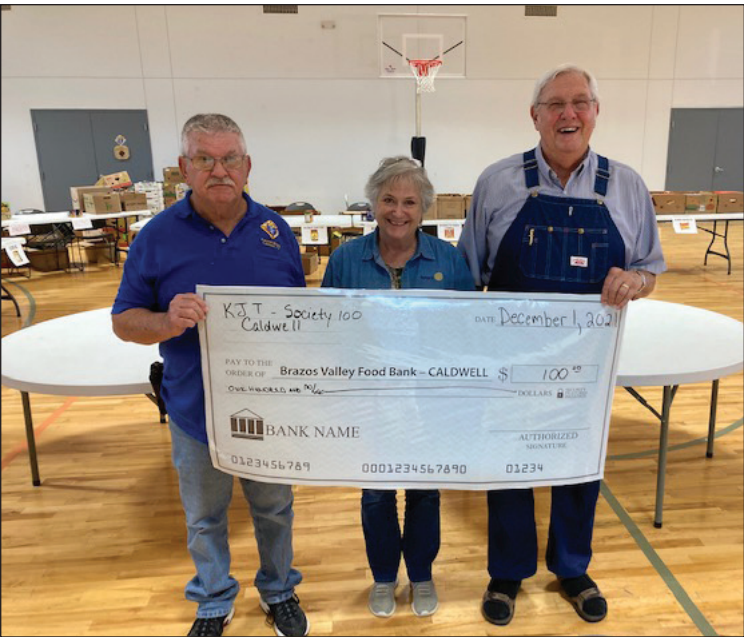
