THE RELIGIOUS SCHOLARSHIP PROGRAM OF THE CATHOLIC UNION OF TEXAS

The Catholic Union of Texas, The KJT, is a religious fraternal organization founded in 1889 near La Grange, Texas. One of the principles in the KJT Charter is the propagation and support of the Roman Catholic religion. One of the ways in which this is accomplished is through financial scholarships awarded to members studying for the priesthood or permanent diaconate.

The present amount of the scholarship for seminarians is \$6,200 payable in the following amounts as the recipient progresses through his studies:

Propaedeutic Year	\$300.00	College IV	\$400.00	Theology II	\$800.00
College I	\$300.00	Pre-Theology I	\$400.00	Pastoral Year	\$800.00
College II	\$300.00	Pre-Theology II	\$500.00	Theology III	\$800.00
College III	\$300.00	Theology I	\$500.00	Theology IV	\$800.00

In addition to the annual payments above, the KJT offers a monetary gift upon ordination.

The present amount of the scholarship for permanent deacon candidates is \$4,200 payable in the following amounts as the recipient progresses through his studies:

Formation Years I-II	\$500 per year
Formation Years III-VI	\$800 per year
Ordination	Monetary gift

PLEASE NOTE:

The applicant for a religious scholarship must be a member of the Catholic Union of Texas, The KJT, and must be studying for a diocese located in the state of Texas.

To qualify for the entire annual scholarship the application must be received by July 31, 2024. The amount awarded is payable in two increments: one half the first semester and one half the second semester. If the application is not received by July 31, 2024, only the second semester payment will be made.
