

## 2024-2025 K-8 Tuition and Guidelines

Sacred Heart School is a very important part of the Catholic faith-forming and educational program at Sacred Heart Parish. Over one hundred years ago, our parishioners built the School and they continue to generously contribute their time, talent, and financial resources to its functioning. We are proud of our parishioners and all who actively participate and support our parish school.

While faith-formation and education take place in the classrooms of Sacred Heart School, we recognize that the most important part of faith formation occurs in the home and the parish-community. Weekend liturgies, as well as other activities appropriate to the students' ages and interests, greatly influence their faith development.

Financial resources for the operation of Sacred Heart Catholic School are derived solely from student tuition and a subsidy provided by Sacred Heart Parish. The approximate cost to educate each student for one year is \$ 6,550. Each student's education is subsidized by Sacred Heart Parish. A concern always exists that this system may become inadequate when school families are not active and supportive members of the parish. When families register at Sacred Heart Catholic School, they are committed to being an active presence in community worship, in contributing their time and talents, and in financial support to the parish.

\*Registration Fee: \$360 and \$200 per additional child.

The Non-Refundable Registration Fee is due at the time of registration.

## AFFILIATED PARISH TUITION RATES

To qualify for Catholic Parish Tuition Rates, each family must be an active contributing member at Sacred Heart or another Catholic Parish. A letter of Good Standing must be submitted from your home parish if you belong to a parish other than Sacred Heart.

- The Registration Fee is required at the time of registration. Each child is placed on the class list according to the paid \$360 Registration Fee. If the class list becomes full, the child will be placed on the waitlist. The Registration Fee is Non-Refundable.
- Monthly payments will vary depending on when a family registers.
- Each family will be assessed a one-time \$200 Legacy Fee at the time of the first tuition payment (only one Legacy Fee per family). You will still receive 20 tickets for our Legacy Fund Raffle in mid-December that you may sell to family and friends in order to recoup your \$200 fee. Held annually in the Spring, the Legacy Fund Raffle is our one major fundraiser for the year and it helps to keep our tuition costs down while continuing to provide a quality education.
- The FACTS Tuition Management Program will be used by all families to pay all tuition fees.
